- **Description of content:** The notified draft Technical Regulation covers the following: Purpose; Scope; Definitions; Product requirements; Labelling requirements; Sampling; Conformity assessment tests; Reference documents; Conformity assessment procedure; Monitoring and inspection authority; Penalty regime; Liability of conformity assessment bodies; and Review and updating.

7. Objective and rationale, including the nature of urgent problems where applicable: The notified Technical Regulation lays down the requirements to be met by chocolate, with a view to preventing risks to human life and health and practices likely to mislead or deceive consumers.

It applies to chocolate manufactured in, imported into or marketed in Ecuador, for example:

- sweet (plain) chocolate;
- unsweetened chocolate:
- couverture chocolate:
- milk chocolate:
- white chocolate;
- diet chocolate;
- flavoured chocolate;
- composite chocolate;
- filled chocolate;
- other chocolate products;
- chocolates or pralines;
- gianduja chocolate;
- gianduja milk chocolate;
- drinking chocolate ("chocolate a la taza");
- drinking chocolate ("chocolate familiar a la taza").
