- 4. Products covered (HS or CCCN where applicable, otherwise national tariff heading. ICS numbers may be provided in addition, where applicable): Atta wheat flour, (ICS: 67.000)
- **5. Title, number of pages and language(s) of the notified document:** Atta wheat flour, (7 pages in Arabic, 6 pages in English).
- **6. Description of content:** This draft technical regulation specifies the requirements stated in the Gulf standard GSO "Atta wheat flour" under clauses 8.1 & 9 (packaging & labelling) as mandatory requirements. The packaging shall be according to GSO standards No. 839 "General Regulations for Food Containers" and shall take into account the following:
 - The product shall be packed in containers which protect the health and nutritional, technical and physical characteristics.
 - That containers shall be manufactured from safe and suitable materials for the purpose of use. And must not cause transferring of toxic substances, objectionable odour and flavors to the product.
 - When the product is packed, the containers shall be new, clean, strong, sewed and sealed with a strong thread
 - The containers shall be with low permeability to moisture and able to protect the flour from insects and pollution.

It also describes following label requirements such as:

- 1. The labeling should be without prejudice to the provisions of Gulf standard GSO 9 "Labeling of prepackaged foods" and GSO 150 "Expiration periods at food products";
- 2. Labelling and adjoining explanatory statements shall be in written in Arabic and

any other language. All the information provided in another language shall be identical with those written in Arabic.

- 3. The following shall be declared on the label of the product:
 - Name of the product (Atta wheat flour);
 - Food additives in the case of addition;
 - Names and quantity of fortification materials in 100 grams in the case of addition;
 - The name and address of the manufacturer;
 - Net weight in grams or kilogram;
 - Batch number;
 - Production and expiration dates.
- 7. Objective and rationale, including the nature of urgent problems where applicable: To maintain consumer protection and food safety.
- 8. Relevant documents:
 - GSO "Atta wheat flour"
 - CODEX STAN 152 "Standard for Wheat Flour"
 - Indian Standard "SPECIFICATION FOR WHEAT ATTA" (SECOND REVISION).
 - GSO 839 for "General Regulations for Food Containers".
