| 6. | Description of content: The notified draft technical regulation specifies the mandatory requirements of packaging & labelling which are stated in the document under clauses 7 & 8 respectively. They are illustrated as follows: <ul style="list-style-type: none">• The Whole chilled chicken and its part are packed in a healthy, clean appropriate package.• The chilled chicken shall be stored at temperature of 0°C to +5°C and away from heat sources and pollution. In addition to the requirements of the Gulf Standard for Labelling of Pre-packaged Foods, the following provisions apply: <ul style="list-style-type: none">• Date of slaughter and the expiration date in a clear manner without (day- month - year).• The word "chilled" shall be written in green color at a clear place.• Storage conditions shall be declared on the label.• Store at temperature of 0°C to 5+ °C shall be declared on the label.• The labelling and adjoining explanatory statements shall be written in Arabic and, where another language is used, it shall be alongside the Arabic. All the information provided in another language shall be identical with those written in Arabic. |
