4.	<b>Products covered (HS or CCCN where applicable, otherwise national tariff heading. ICS numbers may be provided in addition, where applicable):</b> Bread and bakery products (HS 1905). Bread, pastry, cakes, biscuits and other bakers' wares, whether or not containing cocoa; communion wafers, empty cachets of a kind suitable for pharmaceutical use, sealing wafers, rice paper and similar products.
5.	<b>Title, number of pages and language(s) of the notified document:</b> Technical regulation on the characterization, production and sales presentation of bread and bakery products (14 pages, in Lithuanian)
6.	<b>Description of content:</b> Technical regulation on the characterization, production and sale of bread and bakery products is designed to define and classify various bread and bakery products, to set the basic raw material used in the production also to identify general technological requirements, quality and safety indicators. In addition technical regulation sets out labelling, importation and marketing requirements for bread and bakery products. This regulation does not apply to bread and bakery products that are manufactured using a special heat treatment technology - extruding.
7.	<b>Objective and rationale, including the nature of urgent problems where applicable:</b> Currently in Lithuania, bread and bakery products are produced by optional technical documents: Lithuanian standards or corporate standards. These products are not covered by EU legislation. Therefore, quality and safety indicators of bread and bakery products are highly variable and sometimes disadvantageous for consumers. The aim of the regulation - to set definitions of bread and bakery products, to identify raw materials, safety and quality requirements of the production. Also, to set general technological requirements, define safety and quality indicators of the finished product, and common requirements of presentation.
