Description of content: The main purpose of the draft Resolution "On Approval of the Technical Regulation on ecological labelling" is an establishing and enforcement of ecological labeling and introducing accurate, transparent and accessible system to inform consumers about the environmental aspects and improved environmental performance of products on the market of Ukraine. The Technical Regulation establishes the rules on ecological labelling with consideration of the requirements of Regulation (EC) No 66/2010 of the European Parliament and of the Council of 25 November 2009 On the EU Ecolabel.

Objective and rationale, including the nature of urgent problems where applicable: The aim of the proposed measure is to stimulate market participants to improve the environmental performance of production and lead to the facilitation of international trade through approximation of the Ukrainian legislation to EU regulations.
