  - 3. Food utensils, food containers or packaging containing polyvinyl chloride (PVC) or polyvinylidene dichloride (PVDC) plastic materials that are in contact with food, shall be labelled "don't contact food with oil and high temperature directly" or other synonymous expressions
- 7. Objective and rationale, including the nature of urgent problems where applicable: Consumer information
