It revokes letter "b" of item VII of subsection 3.2; the section "e" of item 3.5.1, section "g" of item 4.2 of Annex I and item 5 of Annex II, all of them of Ordinance 13, 30 November 2004 (Instrução Normativa 13, de 30 de Novembro de 2004).
