- 6. **Description of content:** Draft Amendment to Supreme Decree No. 61 of 2012 of the Ministry of Energy, approving the energy labelling regulations for the indicated light motor vehicles. The notified Amendment extends the scope of Supreme Decree No. 61 to include other types of vehicles such as light commercial vehicles, medium vehicles, pure electric vehicles and hybrid vehicles.
- 7. Objective and rationale, including the nature of urgent problems where applicable: Supreme Decree No. 61 of 2012 of the Ministry of Energy established a national system for the labelling of vehicles in Chile. This system was designed to provide information on the energy consumption of vehicles, which had previously been unavailable, and to implement a national system to measure and monitor the energy consumption of new light vehicles. Given the manner in which this measure is applied, it was deemed appropriate to include other types of vehicles such as light commercial vehicles, medium vehicles, pure electric vehicles and hybrid vehicles.
