Title, number of pages and language(s) of the notified document: Draft Commission Regulation (EU) amending, for the purposes of its adaptation to technical and scientific progress, Regulation (EC) No 1272/2008 of the European Parliament and of the Council on classification, labelling and packaging of substances and mixtures (14 pages, in English).
6.	Description of content: The purpose of this draft proposal for a tenth adaptation to technical progress of Regulation (EC) 1272/2008 on classification, labelling and packaging of substances and mixtures (the CLP Regulation) is to amend table 3.1 to Annex VI to the CLP Regulation by introducing new and revised entries for the harmonised classification and labelling of 37 substances and the Acute Toxicity Estimates (ATE) for nicotine. It further amends Annex VI to the CLP Regulation by adding a provision on ATE, by replacing the references to Table 3.1 by references to Table 3 and by deleting references to Table 3.2 and to Directives 67/548/EEC and 1999/45/EC in view of the repeal of these Directives.
7.	Objective and rationale, including the nature of urgent problems where applicable: Ensuring the proper functioning of the EU internal market; Protection of Human health or Safety; Protection of the environment
