- 5. Title, number of pages and language(s) of the notified document: On the introduction of changes and additions to the Regulation of the Government of the Republic of Tajikistan from 1 August 2015, No. 498 "On Technical Regulation of products' safety designed for children and adolescents".
- 6. Description of content: To introduce the following changes and additions to the Technical Regulation of product's safety, designed for children and adolescents, approved by the Decree of the Government of the Republic of Tajikistan from 1 August 2015, No. 498:

In clause 7 add sub-paragraph of following content:

- Artificial fibres fibres, obtained from the chemical processing of natural highmolecular compounds or their transmutation products (viscose, acetate, cuproammonium and etc.)
- Synthetic fibres is polyester, polycaproamide, acryl, polyvinylchloride, polyvinyl alcohol, polyolefine, polyurethane and other fibres, obtained from synthetic polymers by chemical synthesis"

After clause 56 add clauses 57 and 58 with the text of the following content:

- 57. Permissible nesting of synthetic fibres and threads in the textile materials of school uniforms of all age groups should not exceed 30-35% in products of blouse and shirt assortment and 40% in suit, dress assortment. The lining must be made from natural and (or) artificial fibres (viscose).
- 58. The school uniform should have comfortable style, excluding the squeezing the body surface and providing free movement, to provide the thermal comfort of the organism with the view of the season."
