- **6. Description of content:** This Draft East African Standard specifies the requirements, methods of sampling and test for fortified wheat flour prepared from common wheat. Triticum aestivum L. or club wheat, Triticum compactum Host, or mixtures thereof intended for human consumption. It does not apply to wheat flour obtained from Triticum durum.
- 7. Objective and rationale, including the nature of urgent problems where applicable: Trade facilitation; Quality requirements; Protection of Human health or Safety; Prevention of deceptive practices and consumer protection
