 - To introduce a safety management system for biocides, with a view to ensure that all citizens use biocides in a safe way.
 - To transfer the provisions related to product of risk concerns (Article 33, 34, 36 and 37) under the Act on Registration, Evaluation, etc. of Chemical Substances, and to impose more responsibilities and heavier penalties on the product manufacturers and importers.
