- **5. Title, number of pages and language(s) of the notified document:** *Etiquetado facultativo de vinos libres de gluten* (Voluntary labelling of gluten-free wine) (10 pages, in Spanish)

Description of content:** The notified text stipulates that wine establishments may choose to display the words "Gluten-free" or "Free of wheat, oats, barley and rye" and the mandatory symbol to identify gluten-free wines. Where wine establishments exercise this option, they must comply with the measures set out in the notified text. The notified text also formalizes the method for determining gluten in wine through ELISA (enzyme-linked immunosorbent assay) testing.
