It does not apply to security doors, heavy-duty non-residential doors such as those used in industrial warehouses, or rolling walls for access by the public and/or by vehicles or animals. It does not apply to aluminium curtain walls, although the moving or opening parts of such walls must meet the requirements established in this Standard.
