Title, number of pages and language(s) of the notified document:</b> Draft Commission Delegated Directive amending, for the purposes of adapting to scientific and technical progress, Annex III to Directive 2011/65/EU of the European Parliament and of the Council as regards an exemption for lead in dielectric ceramic in certain capacitors (7 pages + Annex 2 pages, in English)
<b>6. Description of content:</b> This draft Commission Delegated Directive concerns an application specific and temporary exemption from the RoHS 2 (Directive 2011/65/EU) substance restrictions.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> Adaptation of existing legislation to scientific and technical progress, granting manufacturers adequate transition time for compliance.
<b>8.
