Description of content:</b> The purpose of this draft proposal for an adaptation to technical progress of Regulation (EC) 1272/2008 on classification, labelling and packaging of substances and mixtures (the CLP Regulation) is to amend Table 3 of Part 3 of Annex VI to the CLP Regulation, by introducing new and revised entries for the harmonised classification and labelling of 63 substances and by deleting 1 entry.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> Ensuring the proper functioning of the EU internal market; Protection of human health or safety; Protection of the environment
