## NOTIFICATION OF CATEGORY COMMITMENTS UNDER THE AGREEMENT ON TRADE FACILITATION

## COMMUNICATION FROM BRAZIL

The following communication, dated 16 March 2017, is being circulated at the request of the delegation of Brazil for Members' information.

In accordance with Article 15 and 16 of the Trade Facilitation Agreement (WT/L/931) and pursuant to the notification submitted on 29 July 2014 (WT/PCTF/N/BRA/1), the Brazilian Government has the honour to notify that Brazil seeks to designate additional provisions of the Agreement on Trade Facilitation as Category A commitments. In this regard, Brazil hereby designates all of the provisions contained in Section I of the Agreement under Category A, which will be implemented upon entry into force of the Agreement, except for the following:

- Article 7.1;
- Article 7.7.3; and
- Article 11.9.

In addition, Brazil designates as Category B commitments the following provisions of the Agreement, with the corresponding indicative dates for implementation specified as required in Article 16.1.a:

- Article 7.1 (31 December 2017);
- Article 7.7.3 (31 December 2017); and
- Article 11.9 (31 December 2019).
