COMMUNICATION FROM CAMBODIA

The following communication, dated 30 August 2017, is being circulated at the request of the delegation of Cambodia for Members' information.

Pursuant to Article 15 and Article 16 of the Agreement on Trade Facilitation ("the Agreement"), the Royal Government of Cambodia has the honour to notify the Committee on Trade Facilitation that Cambodia hereby designates all of the provisions contained in Section I of the Agreement under Category A, which will be implemented upon entry into force of the Agreement, *except* for the following:
