NOTIFICATION OF CATEGORY COMMITMENTS UNDER THE AGREEMENT ON TRADE FACILITATION

COMMUNICATION FROM THAILAND

The following communication, dated 24 May 2017, to the Committee on Trade Facilitation, is being circulated at the request of the delegation of Thailand for Members' information.

Pursuant to Article 16 of the Agreement on Trade Facilitation ("the Agreement"), the Royal Thai Government has the honour to notify the Committee on Trade Facilitation that Thailand has designated as Category B commitments all of the provisions contained in Section I of the Agreement that have been excluded from Category A commitments in accordance with notification WT/PCTF/N/THA/1/Add.1 submitted on 19 September 2016.

The indicative dates from the entry into force of the Agreement for the implementation of Category B commitments are as follows:
