## WTO STRUCTURED DISCUSSIONS ON INVESTMENT FACILITATION FOR DEVELOPMENT

PROPOSED SCHEDULE OF MEETINGS<sup>1</sup>

January – May 2020

Revision

1. The proposed schedule of meetings up to May 2020 has been prepared under the Coordinator's responsibility, based on the suggested dates circulated to all WTO Members in December 2019.<sup>2</sup>

2. Following the decision taken by participating Members to move into negotiating mode as of the first substantive meeting this year<sup>3</sup>, and with a view to assisting Members in further developing the elements of a multilateral framework on investment facilitation for development in the lead-up to the Twelfth WTO Ministerial Conference (MC12), the meetings during the first semester of 2020 will continue to be organized thematically based on the broad topics of the streamlined text prepared by the Coordinator under his responsibility and circulated to all WTO Members on 17 January 2020.<sup>4</sup>

3. Each of the three substantive meetings – in March, April and May – will allow participating Members to review all the elements of the streamlined text, as well as of any other available text proposals or contributions, on a thematic, element-by-element basis. At every meeting, Members will have the opportunity to revert to issues discussed at previous meetings or raise any other investment facilitation-related issues they may wish. The Coordinator may convene additional intersessional meetings as appropriate.

4. Work will continue to be Member-driven and outcome-oriented. Members are encouraged to actively participate in the discussions and to provide their concrete views/positions on the different issues under consideration at each meeting.

5. In keeping with the open, transparent, and inclusive nature of the discussions, all WTO Members are invited and encouraged to participate in the meetings.

6. The proposed schedule of meetings is without prejudice to the position of any Member on the issues under discussion.
