**NOTIFICATION OF OTHER INTELLECTUAL PROPERTY LAWS
AND REGULATIONS UNDER ARTICLE 63.2
OF THE TRIPS AGREEMENT**

KINGDOM OF BAHRAIN

By means of a communication received on 20 April 2014, the Delegation of Bahrain has submitted the following updated notification of its Other laws and regulations under Article 63.2 of the Agreement.

Reference is made to Articles 3, 4 and 5 of the Agreement on Trade-Related Aspects of Intellectual Property Rights in conjunction with Article 63.2 of the same Agreement, and the Decision of the Council for Trade-Related Aspects of Intellectual Property Rights of 21 November 1995. I would hereby like to confirm the commitment of The Kingdom of Bahrain for the full implementation of the TRIPS Agreement. Furthermore, we enclose herewith a complete set of the Kingdom of Bahrain laws and regulations relating to intellectual property rights (copyright and industrial property rights). (See Annex I.)
