<p>Various amendments to the Copyright, Designs and Patents Act 1988.</p> <p>The Regulations implement the Directive of the European Parliament and the Council on the enforcement on intellectual property rights (Directive 2004/48/EC) ("the Enforcement Directive") and make some amendments to further implement the Agreement establishing the World Trade Organization (including the Agreement on Trade-Related Aspects of Intellectual Property Rights), the Directive of the European Parliament and of the Council on the legal protection of designs (Directive 98/71/EC), Council Regulation (EC) No. 6/2002 on Community designs and the European Economic Area Agreement.</p>
