| <p>The approval of the optional registration regulation for copyright works is based on the objectives, competencies, and tasks entrusted to the Saudi Authority for Intellectual Property in accordance with Article (3) of the Authority's regulation issued by Cabinet Resolution No. 496, which stipulates that the Authority aims to regulate, support, develop, sponsor, protect, enforce and upgrade the fields of intellectual property in the Kingdom in accordance with the best international practices, and that in order to achieve its goals, it has the right to register intellectual property rights, grant them protection documents, and enforce them. The board of Saudi Authority for Intellectual Property issued the resolution No. (3-7-2019), dated 12-2-2019 to approve the optional registration regulation for copyright.</p> | |
