<b>Brief description of the notified legal text</b>  The Law aims to protect the intellectual property interests of applicants and rightholders during the martial law regime, imposed due to the military aggression of the Russian Federation against Ukraine. The Law includes provisions relevant to maintaining the validity, use period and enforcement of intellectual property rights during and after the state of the war. The Law also suspends deadlines for examination procedure of applications as well as for other actions related to granting of intellectual property rights during the martial law regime.
