DOMESTIC SUPPORT IN THE WTO AGREEMENT ON AGRICULTURE (AOA)

SUBMISSION FROM CANADA, ARGENTINA, AUSTRALIA, BRAZIL, GUATEMALA, NEW ZEALAND, PARAGUAY, PERU AND URUGUAY

The following submission, dated 5 July 2018, is being circulated at the request of the aforementioned <u>Cairns Group Members</u>.

1 ADDRESSING DOMESTIC SUPPORT

- 1.1. Global agriculture trade patterns have changed significantly since the launch of the Doha Round in 2001. In the view of many Members, the negotiation of new rules should reflect this current situation. In regard to agriculture domestic support, updated analysis with recent data can help illustrate how distorting domestic support has evolved since 2001 and to inform discussions on how disciplines in the AoA should be strengthened to reflect the current trade reality and trends. This paper aims to contribute to a detailed technical discussion on domestic support by reviewing the domestic support categories in the AoA article by article. Specifically, the analysis addresses the following questions:
 - 1) How does Article 6 of the AoA treat and account for domestic support provided by Members?
 - 2) How has support under Article 6 and the Green Box evolved since 2001?
 - 3) How does Annex 2 of the AoA (i.e. the Green Box) account for domestic support provided by Members?
- 1.2. The analysis in this paper is a first step in examining the existing agriculture domestic support categories in the AoA. A detailed analysis of each domestic support provision to enhance Members' understanding is timely, and could inform the development of new and effective rules on domestic support.

2 METHODOLOGY

- 2.1. The analysis presented in this paper uses Members' domestic support notifications from 2001 to 2014 for selected WTO Members that are significant agriculture exporters, importers, or producers. To allow for ease of comparison across this group of Members, notified amounts were converted into nominal US dollars. Value of production (VoP) data is used to provide a comparison of support relative to the size of Member's agriculture sector. Where a Member notified VoP data, this was used in the analysis, otherwise VoP data was sourced from the Food and Agriculture Organization (FAO).
- 2.2. One limitation in this analysis is that not all of the sample group of Members are up to date in their domestic support notifications. Members are encouraged to ensure their notification obligations are met on time and are up-to-date. This will help advance our collective understanding of the current situation with respect to domestic support, and help inform our ongoing negotiations.

3 PRELIMINARY OBSERVATIONS

3.1 Article 6 - Domestic Support Trends

- 3.1. The amount of trade and production distorting domestic support under Article 6 of the AoA for some large traders and producers relative to their respective VoP is increasing. This is the case for Members such as China, India, Indonesia and the Russian Federation.
- 3.2. Trade and production distorting support under Article 6 of the AoA relative to VoP is decreasing for another group of large traders. This is the case for Brazil, Canada, the European Union (EU) and the United States (US).
- 3.3. Since 2001, in nominal terms, several developing Members such as India, China, Indonesia and Brazil recorded large increases in spending in this category, while developed Members such as the US and the EU have significantly reduced their use.
- 3.4. The list of the main users of Article 6 has significantly evolved since 2001. In 2001, the top five users were, in order, the EU, the US, India, Japan and Norway. In 2010, the top five largest users were, in order, India, China, the EU, Japan and the US.

3.2 Article 6.2 - Investment Subsidies or Input Subsidies

- 3.5. While 124 Members are eligible to provide support under Article 6.2, since 2001, only 52 Members have notified Article 6.2 support.
- 3.6. The total amount of notified Article 6.2 support has increased significantly since 2001, however, much of this support is concentrated to only a few Members. While the nominal amount of Article 6.2 support has been steadily increasing for most Members covered in this analysis, as a percentage of VoP it has remained relatively stable.

3.3 Article 6.3 - Final Bound Total AMS (FBTAMS) and Current Total AMS (CTAMS)

- 3.7. In general, the level of applied support (i.e. Current Total Aggregate Measurement of Support (AMS)) notified has been declining since 2001. This has generally resulted in increased "water" between Current Total AMS notified and Members' Final Bound Total AMS (FBTAMS) Commitment in their schedules.
- 3.8. For some Members, such as the EU and US, the notified level of Current Total AMS has remained relatively constant since 2010.
- 3.9. For some Members, such as Argentina, Japan and Norway, the amount of notified Current Total AMS has been relatively unchanged since 2001.

3.4 Article 6.4 - De minimis

- 3.10. Overall, *de minimis* support has increased in nominal terms and these entitlements continue to increase for most Members as the VoP increases, however, *de minimis* support as a percentage of the VoP has remained relatively stable since 2001 and generally remains well below *de minimis* levels permitted under the AoA or in acceding Members Protocols of Accession. More analysis is needed to determine if this is the case for product specific *de minimis*. Product specific *de minimis* support has significantly increased for some large traders since 2001 such as, China, the EU, India, the Russian Federation and the US.
- 3.11. Non-product specific *de minimis* support has increased since 2001 for Brazil, Canada, China, the EU, Japan and the Russian Federation.

3.5 Article 6.5 - Production-Limiting Programmes (Blue Box)

3.12. Blue Box support has been provided by a few Members, with significant amounts of nominal Blue Box support being provided by the EU, Japan and Norway. Nonetheless, overall Blue Box support in both nominal and percentage terms have been decreasing over time.

3.6 Annex 2 - Green Box

- 3.13. Domestic support notified under Annex 2 of the AoA (Green Box) has increased since 2001 for some large traders and producers including the EU, the US, China and India.
- 3.14. The type of Green Box support provided varies by Member. Depending on the Member, support is focused on General Services (e.g. Australia, Argentina, Brazil, Canada, China, Japan), direct payments (e.g. EU, Mexico and Norway), domestic food aid, (e.g. US, Indonesia), or public stockholding (e.g. India).
- 3.15. Except for China and Japan, all Members in the analysis reported an increase in Green Box support relative to their VoP between 2001 and 2010. However, since 2010 support in Green Box relative to VoP has generally been decreasing.

4 ARTICLE 6 AND ANNEX 2 OF THE AOA AND CURRENT TRENDS IN LEVELS OF SUPPORT

- 4.1. Article 6 of the AoA outlines all types of domestic support that do not meet the criteria of Annex 2, AoA (i.e. Green Box). This includes distorting forms of support that are limited, as well as others that are exempted from any quantitative limit. Some Members are limited in the amount of AMS that is fixed in monetary terms in Members' schedules and referred to in Article 6.3 of the AoA, and the majority of Members are limited in the amount of distorting support they can provide relative to a Members VoP (i.e. *de minimis* support outlined in Article 6.4). Some distorting support that would otherwise be included in the calculation of current total AMS commitment, is exempt from these limits if certain criteria are met (e.g. Article 6.2 programmes or production-limiting support in Article 6.5 "Blue Box").
- 4.2. Tables 1 and 2 below show a selection of WTO Members¹ notified Article 6 support between 2001 and 2014. Table 1 shows nominal support converted to US dollars and Table 2 shows support as a percentage of VoP.

¹ This group of Members is either in the top 10 in global agriculture exports or imports (or both) in 2016 according to the World Trade Statistical Review for 2017.

4.1 Article 6.2 of the AoA

- 4.3. Article 6.2 in the AoA, sometimes referred to as the "Development Box", allows most developing country Members² to exempt certain types of domestic support that would otherwise be included in the calculation of a Member's Current Total AMS. There is no limit on the amount of Article 6.2 support, provided the support meets one of the following criteria:
 - Certain investment subsidies, that are generally available to agriculture.
 - Certain <u>input subsidies</u>, that are generally available to low-income or resource-poor producers.
 - Support for diversification from illicit narcotic crops.
- 4.4. The majority of developing country Members have not notified support under Article 6.2. Fifty-two (52) developing country Members have notified domestic support under Article 6.2 for at least one year between 2001 and 2014.

² As part of its Protocol of Accession, China could provide support through government measures of the types described in Article 6.2, the amount of such support would be included in China's calculation of its Aggregate Measurement of Support ("AMS"). A similar provision was maintained in Kazakhstan's Protocol of Accession regarding support provided under Article 6.2.

4.2 Article 6.3 and Members WTO Schedules - Final Bound Total Aggregate Measurement of Support (FBTAMS)

4.5. Thirty-two (32) Members have a FBTAMS commitment greater than zero in their WTO Schedules. This includes 15 developed and 17 developing Members with the FBTAMS ranging from USD 0.4 million to USD 105 billion. In order to comply with Article 6.3, a Member's Current Total AMS (i.e. actual applied support) must be equal to or lower than the scheduled FBTAMS commitment.

4.3 Article 6.4 - De minimis

4.6. For the majority of Members, the amount of AMS support they can provide is limited by their *de minimis* entitlement. Amounts of domestic support that do not exceed a given percentage of a product's total VoP, or where total non-product specific support does not exceed the agriculture sector's total VoP, are exempt from a Member's Current Total AMS. The *de minimis* percentage for developed country Members is 5% while developing country Members generally have a 10% *de minimis*. A small number of Members that acceded to the WTO since it was established have a *de minimis* percentage of 8.5%.

4.4 What types of Domestic Support are included in the Current Total AMS and Article 6.4 *de minimis* (i.e. the Amber Box)?

- 4.7. Support included in the Current Total AMS calculation is support that <u>does not</u> meet the criteria of Annex 2 (the Green Box) of the AoA, or trade and/or production distorting support that is not exempted under Article 6.2 or 6.5 of the AoA. Common types of support that are included in AMS include:
 - Product specific market price support;
 - Non-exempt direct payments dependent on a price gap;
 - Non-exempt direct payments based on factors of production other than price;
 - Input subsidies;
 - Non-product specific support, including various forms of crop/production insurance.

4.5 Article 6.5 - Blue Box

- 4.8. Under Article 6.5 of the AoA, Members are able to exempt direct payments under "production limiting programmes" from their Current Total AMS under three specific circumstances:
 - If the payments are based on fixed production area and yields (AoA 6.5(a)i);
 - If the payments are made on 85% or less of the base level of production AoA 6.5(a)ii); or
 - If livestock payments are made on a fixed number of head (AoA 6.5(a)iii).
- 4.9. Blue Box programmes differ from Amber Box programmes because they have a "quantitative limit" expressed either as area and yield; a base level of production; or livestock numbers. Production above that limit does not qualify for additional payments hence the Agreement describes them as "production limiting".
- 4.10. There is no limit on the amount of support a Member can provide under Article 6.5. Any Member can provide support under the Blue Box.

4.6 AoA Annex 2 - Green Box

- 4.11. A measure that is classified as Green Box must meet the requirement that it has no, or at most minimal trade or production distorting effects. As well as policy-specific criteria and conditions set out in Annex 2, all Green Box support must meet two criteria:
 - **a.** The support in question shall be provided through a publicly-funded government programme (including government revenue foregone) not involving transfers from consumers; and
 - **b.** The support in question shall not have the effect of providing price support to producers.
- 4.12. The policy-specific criteria and conditions are outlined in paragraphs 2 to 13, Annex 2 of the AoA, and contain the following categories:

4.6.1 General Services

This includes support provided for agriculture research, pest and disease control, training services, extension and advisory services, inspection services, marketing and promotion services, and infrastructure services.

4.6.2 Public Stockholding for Food Security Purposes

This includes expenditures in relation to the accumulation and holding of stocks that are an integral part of a food security programme identified in national legislation. Annex 2 stipulates that the accumulation of stocks shall correspond to predetermined targets, food purchases must be made at current market prices, and sales from stocks must be made at no less than current domestic market prices. If a Member procures stocks at administered prices, the difference between the acquisition price and the external reference price must be accounted for in the AMS.

4.6.3 Domestic Food Aid

4.13. This includes expenditures (and revenue foregone) in relation to the provision of domestic food aid to sections of the population in need. Food purchases for domestic food aid must be made at current market prices.

4.6.4 Direct Payment to Producers

- 4.14. This category includes a number of payments made to producers and must conform to the policy specific criteria applying to the different types of direct payments which include:
 - a) Decoupled income support;
 - b) Government financial participation in income insurance and income safety net programmes;
 - c) Payments made for relief from natural disasters;
 - d) Structural adjustment assistance provided through producer retirement programmes;
 - e) Structural adjustment assistance provided though resource retirement programmes;
 - f) Structural adjustment assistance provided through investment aids;
 - g) Payments under environmental programmes;
 - h) Payments under regional assistance programmes.
