Brief description of the notified legal text	
The notified legal text consists of rules for the procurement of public construction, purchase, and service contracts. Both laws are subdivided into seven chapters who contain rules regarding the general provisions, the allocation of public procurement, the allocation of concessions, administration and execution, means of legal redress, sanctions as well as transitional and final provisions.	

With the revision of the Law on Public Procurement and the Law on Sectoral Public Procurement, Liechtenstein has implemented the following regulations into national legislation:
