THE THRESHOLDS IN APPENDIX I OF THE AGREEMENT ON GOVERNMENT PROCUREMENT, AS EXPRESSED IN NATIONAL CURRENCIES FOR 2020-2021

NOTIFICATION FROM THE EUROPEAN UNION

Pursuant to the agreed procedures (GPA/1, Annex 3), delegations have been invited to notify their respective threshold values in national currencies.

The following notification, dated 17 December 2019, is being circulated at the request of the Delegation of the European Union.

These thresholds are effective via Commission Delegated Regulations (EU) N $^{\circ}$ 2019/1827, No. 2019/1828, No. 2019/1829 and No. 2019/1830 as well as Commission Communication C/2019/7697 of 30 October 2019 published in the EU Official Journal of 31 October 2019:

2 PERIOD OF VALIDITY FOR THE THRESHOLD

The threshold levels provided above will apply to the period starting on 1 January 2020 and ending on 31 December 2021.

3 METHOD OF CALCULATION

The calculation of the thresholds of the Agreement on Government Procurement, expressed in Euro (EUR) and in national currencies, has been based on the average daily Special Drawing Right (SDR) to EUR exchange rate over 24 months from 1 September 2017 through 31 August 2019 (SDR 1 = EUR 1.20917).

The value of the thresholds in Euro and in national currencies has been expressed without the value-added tax (VAT), because the European Union excludes VAT when calculating the value of contracts.
