2 PERIOD OF VALIDITY FOR THE THRESHOLD

The threshold levels provided above will apply to the period 1 April 2020 (the beginning of the fiscal year for 2020) until 31 March 2022 (the end of the fiscal year for 2021).

3 METHOD OF CALCULATION

The calculation of the thresholds is based on the average of the daily exchange rates of the Japanese YEN (JPY) in terms of the Special Drawing Right (SDR) over the two-year period of January 2018 to December 2019 (SDR 1 = JPY 153.430).
