## ANNUAL REPORT OF THE WORKING PARTY ON DOMESTIC REGULATION TO THE COUNCIL FOR TRADE IN SERVICES (2017)

Since its Annual Report of 2016 to the Council for Trade in Services<sup>1</sup>, the Working Party on Domestic Regulation (WPDR) held four formal meetings, respectively on 25 November 2016; 14 March 2017; 15, 16, 22 June and 5 July 2017; and 2-4 October 2017<sup>2</sup>, and two informal meetings, on 27 February and 9 May 2017.<sup>3</sup> During the period covered by this report, the Working Party continued with its work on the development of regulatory disciplines pursuant to GATS Article VI:4.

## **DEVELOPMENT OF REGULATORY DISCIPLINES UNDER GATS ARTICLE VI:4**

1.1. During the formal meeting of 25 November 2016, the Working Party addressed two communications<sup>4</sup> by Members: one communication by a group of Members provided a revised text proposal on "Administration of Measures"<sup>5</sup>; the other communication, by India, contained "Possible Elements of a Trade Facilitation in Services Agreement".<sup>6</sup> Under Other Business, the delegation of Australia proposed to invite the International Organization for Standardization (ISO) to the next meeting of the Working Party to update Members on its recent work on services standards, and to hold a Member-driven exchange of information and experience on services standards.<sup>7</sup>

1.2. During the formal meeting on 14 March 2017, the Working Party addressed three new communications by groups of co-sponsors: one on "Transparency"<sup>8</sup>; and two others on "Development of Measures"<sup>9,10</sup>. India circulated a communication concerning a "Trade Facilitation Agreement for Services<sup>"11</sup>, as well as a presentation on this communication.<sup>1</sup>

1.3. During the formal meeting of the Working Party on 15, 16, 22 June and 5 July 2017, Members addressed new communications by groups of co-sponsors on "Technical Standards"<sup>13</sup>, "Development of Measures, Gender Equality"<sup>14</sup>, and by Australia on "Development (Least Developed Countries)".<sup>15</sup> The delegation of the Dominican Republic submitted a communication containing questions on India's proposal for a Trade Facilitation Agreement for Services.<sup>16</sup>

1.4. At the formal meeting of 2-4 October 2017, the Working Party addressed a communication on "Disciplines on Domestic Regulation"<sup>17</sup>, which brings together earlier negotiating proposals by proponents for domestic regulation disciplines in one document, as well as a communication by India containing comments and text proposals to the above-mentioned text.<sup>18</sup> The delegation of India also circulated its opening remarks made at the meeting.<sup>19</sup> The African Group submitted a communication containing "Questions on Domestic Regulation".<sup>20</sup>
