ANNUAL REPORT (2020)

The present report has been prepared in pursuance of the Procedures for an Annual Overview of WTO Activities and for Reporting under the WTO (WT/L/105).

Since its previous annual report¹, the General Council has held five regular meetings on 3 March, 29 May, 22-23 and 31 July, 13 October, and 16-18 December, a special meeting on 15 May and a General Council meeting with the candidates in the Appointment Process for a new Director-General on 15-17 July². The minutes of these meetings, which remain in the record of the General Council's work, are contained in documents WT/GC/M/182, WT/GC/M/183 and WT/GC/M/183/Corr.1, WT/GC/M/184 and WT/GC/M/184/Corr.1, WT/GC/M/185, WT/GC/M/186, WT/GC/M/187 and WT/GC/M/188.³

1 REPORTS ON INFORMAL TNC AND INFORMAL HODS MEETINGS (WT/GC/M/182; WT/GC/M/184; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)	

1.1. Ministers at Doha established a Trade Negotiations Committee under the authority of the General Council to supervise the overall conduct of the negotiations (WT/MIN(01)/DEC/1). In accordance with the Principles and Practices endorsed by the Trade Negotiations Committee at its first meeting in 2002 (TN/C/M/1), the TNC reports to each regular meeting of the General Council.

1.2. At the March meeting, the Chair recalled that the Director-General had convened Informal TNC and Informal Heads of Delegation meetings on 2 March where he had reported on relevant activities since his previous report and noted that, as per established practice, the Director-General's report, the reports of the Chairs of negotiating bodies, and the statements delivered by delegations would be included in the minutes of the March General Council meeting. The representatives of Costa Rica, Gabon and Côte d'Ivoire spoke. The General Council took note of the report of the Chairman of the TNC and of the Director-General's report⁴, and of the statements delivered at the Informal TNC and

Informal HODs meetings on 2 March⁵ and by the delegations who took the floor under this item at the March General Council meeting.

1.3. At the May meeting, the Director-General, as Chairman of the TNC, provided his report on the TNC's activities since his last report to the Council, as well as on COVID-19 related matters and on his recent outreach activities. His full report can be found in document JOB/GC/231. The representatives of Chad (LDCs); Botswana (African Group); Burkina Faso (C-4 and the 36 African Country Cotton and Cotton Product Producers and/or Exporters); Costa Rica (Joint Initiative on Services Domestic Regulation); Panama; Uruguay (Informal Working Group on MSMEs); Australia (Joint Statement on E-Commerce); Saint Lucia (CARICOM); Jamaica (ACP); Indonesia; India; South Africa; Vanuatu (Pacific Group); the European Union; Guyana and Switzerland spoke. During its intervention, the representative of Indonesia referred to both items 1 and 2 of the May GC agenda.⁶ The General Council took note of the report of the Director-General and of the statements.⁷

1.4. At the July meeting, as it was his last General Council meeting, Director-General Roberto Azevêdo delivered a farewell statement to the General Council. The Director-General recalled his experience and the highlights during his seven-year tenure. He said that MC12 should deliver credible agreements and map the way for further reforms especially given the economic repercussions in the wake of COVID-19. His full statement can be found in JOB/GC/241.⁸

1.5. The General Council took note of the statements.

1.6. At the October meeting, the Chair recalled that on 12 October, the Informal TNC and Informal Heads of Delegation meetings had been convened by the four Deputy Directors-General in coordination with him as General Council Chair. The Deputy Directors-General and he had thought that during the interim period, it would be useful to have a "no surprises" approach, and that included continuing to provide the important usual transparency and inclusiveness in the HODs/TNCs – for Members to update each other on their activities and express views on the way forward ahead of the General Council meeting. Deputy Director-General Agah, representing all DDGs, chaired the meeting and had provided a report on recent activities. As per past practice, the report of Deputy Director-General Agah, representing all DDGs, the reports of the Chairs of negotiating bodies, and the statements delivered by delegations during the Informal TNC and Informal HODs meetings were included in the minutes of the October General Council meeting. The representative of Saint Lucia

(CARICOM) spoke. The General Council took note of the report⁹ of Deputy Director-General Agah, representing all DDGs, on 12 October, and of the statement that day as well as those delivered at the 12 October Informal TNC and Informal HODs meetings.¹⁰

1.7. At the December meeting, the Chair recalled that the Informal TNC and Informal Heads of Delegation meetings was convened on 14 December by the four Deputy Directors-General in coordination with him as General Council Chair. They continued in line with the understanding that had been reached at the July meeting of the General Council – that reflecting the existing and appropriate boundaries of governance, the Deputy Directors-General would undertake their responsibilities in close consultation with Members, where relevant, as represented by the General Council Chair. He recalled that Deputy Director-General Brauner, representing all DDGs, had chaired the meeting and had provided a report on recent activities. As per past practice, the report of Deputy Director-General Brauner, representing all DDGs, the reports of the Chairs of negotiating bodies, and the statements delivered by delegations during the Informal TNC and Informal HODs meetings were included in the minutes of the October General Council meeting. The representatives of El Salvador (Guatemala, Honduras, Panama, Dominican Republic and El Salvador); Oman and Cambodia spoke. The General Council took note of the report¹¹ of Deputy Director-General Brauner, representing all DDGs, on 14 December, and of the statement that day as well as those delivered at the 14 December Informal TNC and Informal HODs meetings.¹²

2 IMPLEMENTATION OF THE BALI, NAIROBI AND BUENOS AIRES OUTCOMES – STATEMENTS BY THE CHAIRPERSON (WT/GC/M/182; WT/GC/M/184; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)

2.1. Since July 2014, the item on implementation of the Bali outcomes has been included on the General Council's agenda at the request of the Chair, to provide an update on the work taking place in the regular bodies which were directly working on the various Bali Decisions. After the Tenth and Eleventh Sessions of the Ministerial Conference, reports on the implementation of the Nairobi and Buenos Aires outcomes were also provided under this item.

2.2. At the General Council meetings in March, May, July, October and December, the Chair reported on the work taking place in WTO regular bodies to fulfil the Bali, Nairobi and Buenos Aires Ministerial mandates.¹³

2.3. At the March meeting, the representatives of Chad (LDCs) and Barbados spoke. The General Council took note of the Chair's report and of the statement.

2.4. At the May meeting, the representatives of Chad (LDCs); Switzerland and the European Union spoke. The General Council took note of the Chair's report and of the statements.

2.5. At the July meeting, the representatives of India; South Africa; Chad (LDCs); Botswana (African Group); Indonesia; Switzerland; the European Union; Sri Lanka and Namibia spoke. The General Council took note of the Chair's report and of the statements.

2.6. At the October meeting, the representatives of Chad (LDCs); the European Union; India and Indonesia spoke. The General Council took note of the Chair's report and of the statements.

2.7. At the December meeting, the representatives of Chad (LDCs); Indonesia; Cambodia; the European Union; India and Morocco¹⁴ spoke. The General Council took note of the Chair's report and of the statements.

3 COVID-19 TRADE-RELATED MATTERS

3.1 Information Sharing and Exchange of Views on COVID-19 Trade-Related Measures (WT/GC/M/183 and WT/GC/M/183/Corr.1)

3.1. The special General Council meeting held in virtual format on 15 May provided a forum for Members to share information and exchange views on COVID-19 trade-related measures. It was the first time that a Special General Council meeting was convened to discuss the trade policy aspects and effects of a global crisis and that a formal WTO meeting was held in virtual format. The Chair highlighted the economic dimensions of the COVID-19 crisis and that trade, or the lack of it, could variously contribute to ameliorating problems or to aggravating the challenges – in both the immediate and longer term. He noted the various initiatives of the WTO in response to the crisis, including the guidance joint statements issued by the Director-General and the monitoring and reporting work of the Secretariat and stressed that Members had been issuing joint political statements calling for keeping markets open; ensuring the free flow of trade in essential medical goods, agricultural and food products; minimising disruptions in supply chains; and for response measures to be transparent, temporary and proportionate, without creating unnecessary barriers to trade. His full statement was circulated in document JOB/GC/228. The Director-General also made a statement on this matter which was subsequently circulated in document JOB/GC/229.

3.2. Trade in Essential Goods for Combating the COVID-19 Pandemic (G/C/W/779 – G/MA/W/151); (c) Responding to the COVID-19 Pandemic with Open and Predictable Trade in Agricultural and Food Products (WT/GC/208 and WT/GC/208/Rev.1 and WT/GC/208/Rev.2); (d) COVID-19: Actions to be Considered during Confinement and after Reopening of the World Trade Organization (WTO) Facilities (RD/GC/13 – RD/TNC/2); (e) ASEAN Declaration and Statements on COVID-19 (WT/GC/210); (f) Securing LDCs' Emergency Access to Essential Medical and Food Products to combat the COVID-19 Pandemic (WT/GC/211); (g) Statement on COVID-19 And the Multilateral Trading System by Ministers Responsible for the WTO from Co-Sponsors (WT/GC/212 and Rev.1 and Rev.2); (h) Statement on COVID-19 by APEC Ministers Responsible for Trade (WT/GC/213) (i) Joint Ministerial Statement on COVID-19 (WT/GC/214); (j) Statement on Highlighting the Importance of MSMEs in the time of COVID-19 (WT/GC/215 and Rev.1); (k) G20 Trade and Investment Ministerial Meeting Ministerial Statement (WT/GC/216).

3.4. The General Council took note of the statements.

3.2 Joint Ministerial Statement on Action Plans to Facilitate the Flow of Goods and Services as well as the Essential Movement of People – Request by the Republic of Korea (WT/GC/M/184)

3.5. At the May meeting, the representative of the Republic of Korea presented the Joint Ministerial Statement circulated in WT/GC/214 and co-sponsored by Australia, Canada, New Zealand and Singapore. The representatives of Chad (LDCs); New Zealand, Australia; Singapore; Kenya; Chinese Taipei; South Africa; India; Canada; the European Union; Afghanistan and Chile spoke. During their respective interventions, Kenya and Chile referred to items 5 and 6 of the May GC agenda.¹⁶ The representative of the Republic of Korea again took the floor. The General Council took note of the statements.

3.3 Garments and Textile Sector in light of COVID-19 – Statement by Bangladesh (WT/GC/M/184)

3.6. At the May¹⁷ meeting, the representative of Bangladesh made a statement on the impact of the behaviour of businesses in light of COVID-19, in particular in the garments manufacturing sector and requested that an event be organised to discuss this matter. The General Council took note of the statement.

3.4 Discussions of the g7+ WTO Accessions Group on COVID-19 – Statement by Afghanistan (WT/GC/M/184)

3.7. At the May¹⁸ meeting, the representative of Afghanistan provided an update on the discussions of the g7+ WTO Accessions Group on COVID-19 where they called on all Members to consider the challenges they faced and to support them in curbing the pandemic and facilitating their economic recovery and resilience. The General Council took note of the statement.

3.5 COVID-19 Initiative: Protecting Global Food Security Through Open Trade – Statement by Co-Sponsors of WT/GC/218/Rev.1 (WT/GC/M/186)

3.8. At the July meeting, the representative of Australia presented the revised communication in document WT/GC/218/Rev.1, on behalf of the co-sponsors, seeking to limit the impacts of COVID-19 by reinforcing the importance of open markets, maintaining global supply chains and transparency. The representatives of Costa Rica; Canada; Argentina; Uruguay; Brazil; Peru; Paraguay; New Zealand; Japan; Chile; the United States; Singapore; Ukraine; China; the United Kingdom; Nigeria; the European Union; the Russian Federation; Pakistan; Qatar; Botswana (African Group); Jamaica (ACP); Chad (LDCs); South Africa; India; Indonesia and Malaysia spoke. During its

intervention, Botswana referred to the African Group Statement on the Implications of COVID-19 in document WT/GC/219 – TN/C/20. The General Council took note of the statements.

3.6 APEC Ministers Responsible for Trade (MRT) Virtual Meeting Joint Statement 2020 – Request from Malaysia (WT/GC/M/187)

3.9. At the October meeting, the representative of Malaysia presented the communication in WT/GC/220. The representatives of Australia; Chile; the United States; Canada; the Philippines; Viet Nam (ASEAN) and Japan spoke. The General Council took note of the statements.

3.7 COVID-19 and Beyond: Trade And Health – Statement by Co-Sponsors of WT/GC/223 (WT/GC/M/188)

3.10. At the December meeting, the representative of the European Union presented the communication in WT/GC/223, co-sponsored by Australia; Brazil; Canada; Chile; Japan; Kenya; the Republic of Korea; Mexico; New Zealand; Norway; Singapore and Switzerland.

3.11. The representatives of Australia; the Republic of Moldova; the Russian Federation; Nigeria; Senegal; Hong Kong, China; Côte d'Ivoire; Chile; Iceland; Colombia; Fiji; Mexico; Costa Rica; Norway; Canada; the Republic of Korea; the United States; New Zealand; Switzerland; Thailand; Chinese Taipei; Guyana (CARICOM); Indonesia; Turkey; Bangladesh; Chad (LDCs); the United Kingdom; Peru; Brazil; Vanuatu (Pacific Group); Mauritius (African Group); India; Singapore; Qatar; Cameroon; Israel; South Africa; Pakistan; the Kingdom of Saudi Arabia; Mali; Cambodia and Oman spoke. The European Union again took the floor. The General Council took note of the statements.

4 WORK PROGRAMME ON ELECTRONIC COMMERCE¹⁹

4.1 Reports by the Chairs of the Council for Trade in Goods and the Council for Trade in Services (WT/GC/M/188)

4.1. At the December meeting, the Chair drew Members' attention to the reports submitted by the Chairs of the Council for Trade in Goods and of the Council for Trade in Services to the General Council, contained in documents G/C/67 and S/C/61, respectively. The Chairs of the Council for Trade in Goods and the Council for Trade in Services introduced those reports and the Chair of the TRIPS Council made a statement on the developments in this area. The Chair then made a statement. The General Council took note of the reports and of the Chairs' statements.²⁰

4.2 Work Programme on Electronic Commerce and Moratorium on Imposing Customs Duties on Electronic Transmissions – Request from India (WT/GC/M/187 and WT/GC/M/188)

4.2. At the October meeting, the representative of India made a statement stressing the importance of discussions under the Work Programme on Electronic Commerce and on the moratorium. The representatives of South Africa; Indonesia; Nigeria; Australia; Botswana (African Group); Bangladesh; Jamaica (ACP); Namibia; Saint Lucia (CARICOM); the United Kingdom; Turkey; the United States; Mali; Mexico; Canada; Switzerland; Israel; Singapore; Japan; Sri Lanka; the European Union; Pakistan; Chad (LDCs) and Chile spoke. India again took the floor. The General Council took note of the statements.

4.3. At the December meeting, the representative of India made a statement on this matter. The General Council took note of the statement.²¹

4.3 Reinforcing the Work Under the 1998 Work Programme on Electronic Commerce – Communication from South Africa and India (WT/GC/M/188)

4.4. At the December meeting, the representative of South Africa introduced the joint communication with India circulated in document WT/GC/W/812.

4.5. The representatives of Uruguay; Peru; the Republic of Korea; Barbados; Turkey; Uganda; Nigeria; Chile; Botswana (African Group); the United States; Chinese Taipei; Indonesia; Chad (LDCs); Pakistan; Japan; Tunisia; Thailand; Guyana (CARICOM); Australia; Mexico; Singapore; Bangladesh; Hong Kong, China; Namibia; Egypt; Sri Lanka; Vanuatu (Pacific Group); the United Kingdom; Switzerland; Senegal; the European Union; Canada; Brazil; the Philippines; Jamaica (ACP); Oman and Israel spoke. South Africa again took the floor and India spoke. The General Council took note of the statements.

5 TRIPS COUNCIL MATTERS

5.1 Annual Review of the Special Compulsory Licensing System – Paragraph 7 of the Annex to the Amended TRIPS Agreement and Paragraph 8 of the Decision on the Implementation of Paragraph 6 of the Doha Declaration on the TRIPS Agreement and Public Health – Report of the Council for TRIPS (WT/GC/M/188)

5.1. In August 2003, the General Council adopted a Decision on the Implementation of Paragraph 6 of the Doha Declaration on the TRIPS Agreement and Public Health. Paragraph 8 of that Decision provided that the TRIPS Council should review annually the functioning of the system set out in the Decision with a view to ensuring its effective operation, and should annually report on its operation to the General Council. In addition, in keeping with the August 2003 Decision, the General Council adopted, in December 2005, a Protocol Amending the TRIPS Agreement, which was submitted to Members for acceptance. In accordance with Article X:3 of the WTO Agreement, the Protocol entered into force on 23 January 2017, upon acceptance by two-thirds of the WTO Members. Both the amended TRIPS Agreement and the 2003 Decision provided that the TRIPS Council should review annually the functioning of the system and should also report on its operation to the General Council.

5.2. At the December meeting, the Chair of the TRIPS Council introduced the report of the Council (IP/C/86 and IP/C/86/Corr.1) on its annual review of the Decision on the Implementation of Paragraph 6 of the Doha Declaration on the TRIPS Agreement and Public Health. The General Council took note of the report of the TRIPS Council and of the statement of the TRIPS Council Chair.

5.2 Status Report on the Consideration by the TRIPS Council of the "Proposal for a Waiver from Certain Provisions of the TRIPS Agreement for the Prevention, Containment and Treatment of COVID-19" – Statement by the Chair of the Council for TRIPS (WT/GC/M/188)

5.3. At the December meeting, the TRIPS Council Chair provided a status report on the "Proposal for a Waiver from Certain Provisions of the TRIPS Agreement for the Prevention, Containment and Treatment of COVID-19" in document IP/C/W/669 and its addenda.²² The representatives of Botswana (African Group); Chile; the Republic of Korea; Jamaica (ACP); Hong Kong, China; Cuba; Australia; South Africa; Malaysia; Afghanistan; Pakistan; Colombia; Turkey; Mongolia; Tunisia; Japan; El Salvador; the European Union; Mozambique; Egypt; Bangladesh; the Dominican Republic; Canada; Singapore; Sri Lanka; Switzerland; Senegal; the United Kingdom; India; Nepal; Chad (LDCs); Indonesia and Nigeria spoke.²³ The Chair noted that the discussion that day had highlighted the importance that Members attached to the issue and encouraged all delegations to remain positively engaged in the further discussions in the TRIPS Council. He thanked the TRIPS Council Chair for her leadership and noted that the TRIPS Council would report back to the General Council in line with Article IX:3 of the Marrakesh Agreement. The General Council took note of the TRIPS Council Chair's report and of the statements.

6 WORK PROGRAMME ON SMALL ECONOMIES – REPORTS (WT/GC/M/182; WT/GC/M/184; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)

6.1. At the March meeting, the CTD Chairman reported that the proposed text for a Ministerial Decision on Small Economies was still under consideration and that there was no objection to proceed with a proposed seminar on the opportunities and challenges for small economies in attracting investments. The representatives of El Salvador (SVEs) and Barbados spoke. The General Council took note of the CTD Chairman's report and of the statements.

6.2. At the May meeting, the CTD Chairman reported that due to COVID-19, the dedicated session scheduled on 26 March was postponed – which could have been used to agree on a text for an MC12 Ministerial Decision on the Work Programme of Small Economies. As MC12 had also been postponed, the CTD Chair would discuss with the SVEs Group regarding the way forward. The representatives of Vanuatu (Pacific Group); Mauritius; Saint Lucia (CARICOM); El Salvador (SVEs) and Barbados spoke. The General Council took note of the CTD Chairman's report and of the statements.

6.3. At the July meeting, the CTD Chairman reported that he had reached out to the SVEs and other delegations and planned to convene a meeting after the summer break to discuss relevant issues. He noted the suggestions by delegations to include topics such as the impact of COVID-19 on trade in small economies and on attracting investments. The representatives of Guatemala (SVEs), Fiji, Saint Lucia (CARICOM), Vanuatu (Pacific Group), Sri Lanka, Burkina Faso (C-4) and Barbados spoke. The General Council took note of the CTD Chairman's report and of the statements.

6.4. At the October meeting, the CTD Chairman reported that he had reached out to the SVEs and other delegations and planned to convene a meeting after the summer break to discuss relevant issues. Delegations suggested topics such as the impact of COVID-19 on the trade of small economies and attracting investments in small economies. The representatives of Barbados; Guatemala (SVEs); Sri Lanka; Ecuador; Saint Lucia (CARICOM); Mauritius; the Republic of Korea and Fiji (Pacific Group) spoke. The General Council took note of the CTD Chairman's report and of the statements.

6.5. At the December meeting, the CTD Chairman reported on the recent discussions on the opportunities and challenges for small economies in attracting investments and the impact of the COVID-19 outbreak on the trade of small economies. A report would be prepared on the work undertaken since MC11 which would also contain the elements of an agreed text for a Ministerial Decision, including on future work. The representatives of Barbados; Fiji; Sri Lanka; Vanuatu (Pacific Islands); Jamaica; Guatemala (SVEs) and Guyana (CARICOM) spoke. The General Council took note of the CTD Chairman's report and of the statements.

7 THE DEVELOPMENT ASSISTANCE ASPECTS OF COTTON

7.1 Action Plan to Enhance Support for Cotton By-Product Development in LDCs – Draft General Council Declaration – Communication from Burkina Faso on behalf of the C-4 and Côte d'Ivoire (WT/GC/M/188)

7.1. At the December meeting, the representative of Burkina Faso (C-4 and the 36 African Country Cotton and Cotton Product Producers and/or Exporters) made a statement on this matter and presented a draft General Council Declaration in document WT/GC/W/808 on behalf of the C-4 and Côte d'Ivoire. Deputy Director-General Wolff and the representatives of Botswana (African Group); Senegal; South Africa; Cameroon; Brazil; Pakistan; the United States; Chad (LDCs); India; Turkey; Jamaica (ACP); the European Union; Nigeria; Tunisia; China; Mozambique; Australia and Haiti spoke. The General Council took note of the statements.

7.2 Statement by Deputy Director-General (WT/GC/M/188)

7.2. At the December meeting, Deputy Director-General Wolff provided a periodic report on the development assistance aspects of the Cotton Initiative and referred to the Report of the 33rd Round of the Director-General's Consultative Framework Mechanism on Cotton in document TN/AG/SCC/W/35 – WT/CFMC/62. The General Council took note of the report of Deputy Director-General Wolff.

8 ACCESSION MATTERS

8.1 2019 Annual Report by the Director-General (WT/GC/M/182)

8.1. At the March meeting, the Director-General presented the 2019 Annual Report on WTO Accessions (WT/ACC/36 – WT/GC/207) and highlighted that 2019 was another busy year for WTO accessions with 14 out of the 22 ongoing accessions being in the "active" category. The representatives of Panama (Article XII Members); Afghanistan; Chad (LDCs); the United States; Uruguay; Botswana (African Group); South Africa; Turkey; the United Kingdom; Benin; Oman; Qatar; Somalia (Observer) and Ethiopia (Observer) spoke. The General Council took note of the Director-General's report and of the statements.

8.2 Curaçao (WT/GC/M/182)

8.2. At the March meeting, the General Council agreed to establish the Working Party to examine the request for accession of Curaçao in document WT/ACC/CUW/1, with standard terms of reference and composition as the Chair read out in the meeting. Mr. Caryl Monte, President of the Permanent Commission for International Trade and Foreign Economic Relations and Chief Negotiator of Curaçao (Observer) and the representatives of the Kingdom of the Netherlands; Panama (Article XII Members); the European Union; Saint Lucia (OECS); Barbados; the United Kingdom; Jamaica and the Dominican Republic spoke. The General Council took note of the statements.

8.3 Somalia (WT/GC/M/187)

8.3. At the October²⁴ meeting, the Chair announced that, following a process of consultations conducted by Deputy Director-General Wolff, there was consensus on the appointment of Ambassador Mikael Anzén (Sweden) as Chairman of the Working Party on the Accession of Somalia. The General Council took note of the statement.

9 OBSERVER STATUS

9.1 Turkmenistan (WT/GC/M/184 and WT/GC/M/186)

9.1. At the May²⁵ meeting, the Chair announced that he would begin consultations on Turkmenistan's request for observer status (WT/L/1090). The General Council took note²⁶ of the Chair's statement.

9.2. At the July meeting, the Chair reported that, further to subsequent engagement with a number of delegations, he had sent a communication on 25 June to suggest that, if no objections or reservations had been received by 3 July, the General Council would consider the request for observer status at its next regular meeting. As he had not received any objections, he understood that the General Council could be in a position to take action on the matter. He therefore proposed that the General Council agreed to the request to grant Turkmenistan Observer Status. The General Council so agreed. H.E. Atageldi Haljanov, Ambassador and Permanent Representative of Turkmenistan in Geneva (Observer) and the representatives of Afghanistan, Panama (Article XII Members), Mongolia (LLDCs), Tajikistan, Ukraine, Turkey, India, the Kyrgyz Republic, Kazakhstan, the Russian Federation, Paraguay and Pakistan spoke. Turkmenistan (Observer) again took the floor. The General Council took note of the statements.

10 WAIVERS

10.1 Introduction of Harmonized System 2002, 2007, 2012 and 2017 Changes into WTO Schedules of Tariff Concessions – Draft Decision (WT/GC/M/188)

10.1. At the December meeting, the General Council considered four draft waiver decisions, contained in G/C/W/782, G/C/W/783, G/C/W/784 and G/C/W/785 which concerned the Introduction

of Harmonized System 2002, 2007, 2012 and 2017 Changes into WTO Schedules of Tariff Concessions, respectively. The Chair of the Council for Trade in Goods reported on the consideration of this matter by that Council. The General Council took note of the report and, in accordance with the Decision-Making Procedures under Articles IX and XII of the WTO Agreement agreed in November 1995 (WT/L/93), adopted the four draft Decisions, including with respect to the request by Ecuador to be added in the Annex to the waivers in G/C/W/784 and G/C/W/785, which were subsequently circulated in WT/L/1104, WT/L/1105, WT/L/1106 and WT/L/1107.

10.2 Review of Waivers Pursuant to Article IX:4 of the WTO Agreement (WT/GC/M/186 and WT/GC/M/188)

10.2. Under Article IX:4 of the WTO Agreement, "[a]ny waiver granted for a period of more than one year shall be reviewed by the Ministerial Conference not later than one year after it is granted, and thereafter annually until the waiver terminates."

10.3. At the July meeting, the General Council considered the following waivers for review under Article IX:4:

- a. Least-Developed Country Members – Obligations under Article 70.8 and Article 70.9 of the TRIPS Agreement with respect to Pharmaceutical Products, granted on 30 November 2015 until 1 January 2033 (WT/L/971)
- b. Kimberley Process Certification Scheme for Rough Diamonds, granted on 26 July 2018 through 31 December 2024 (WT/L/1039)
- c. Canada – CARIBCAN, granted on 28 July 2015 until 31 December 2023 (WT/L/958, WT/L/1091)

10.4. In doing so, the General Council considered a report on implementation of the respective waiver in document WT/L/1091. The representatives of Chad (LDCs), Canada, Jamaica, Saint Lucia (CARICOM) and the European Union spoke. The General Council took note of the report contained in document WT/L/1091 and of the statements.

10.5. At the December meeting, the General Council considered the following waivers for review under Article IX:4:

- a. Preferential Treatment in favour of Services and Service Suppliers of Least-Developed Countries, granted on 17 December 2011 until 31 December 2030 (WT/L/847, WT/L/982)
- b. Preferential Tariff Treatment for Least-Developed Countries, granted on 16 October 2019 until 30 June 2029 (WT/L/1069)
- c. Cuba – Article Xv:6 – Extension of Waiver, granted on 7 December 2016 until 31 December 2021 (WT/L/1003, WT/L/1102)
- d. European Union – Application of Autonomous Preferential Treatment to the Western Balkans, granted on 7 December 2016 until 31 December 2021 (WT/L/1002, WT/L/1103)
- e. United States – African Growth and Opportunity Act, granted on 30 November 2015 until 30 September 2025 (WT/L/970, WT/L/1097 and WT/L/1097/Corr.1)
- f. United States – Caribbean Basin Economic Recovery Act, granted on 16 October 2019 until 30 September 2025 (WT/L/1070, WT/L/1096 and WT/L/1096/Corr.1)

- g. United States – Former Trust Territory of the Pacific Islands, granted on 7 December 2016 until 31 December 2026 (WT/L/1000, WT/L/1098, WT/L/1098/Corr.1²⁷ and WT/L/1098/Corr.2)
- h. United States – Trade Preferences Granted to Nepal, granted on 7 December 2016 until 31 December 2025 (WT/L/1001, WT/L/1099)

10.6. In doing so, the General Council considered a report on implementation of the respective waivers in documents WT/L/1096, WT/L/1096/Corr.1, WT/L/1097, WT/L/1097/Corr.1, WT/L/1098, WT/L/1098/Corr.1, WT/L/1098/Corr.2, WT/L/1099, WT/L/1102 and WT/L/1103. The representatives of Saint Lucia (CARICOM) and Jamaica spoke.²⁸ The General Council took note of the reports and of the statements.

11 TWELFTH SESSION OF THE MINISTERIAL CONFERENCE

11.1 Statement by the Chairperson (WT/GC/M/182)

11.1. At the March meeting, the Chair made a statement on the Annual Reports to be transmitted to Ministers at MC12 and on a possible outcome document. The representative of Barbados spoke. The General Council took note of the statements.

11.2 Election of Officers (WT/GC/M/182)

11.2. At the March meeting, the General Council agreed to elect the following Vice-Chairs for MC12: H.E. Ms Amelia Kyambadde (Uganda), H.E. Mr Jerome Walcott (Barbados) and H.E. Mr Simon Birmingham (Australia).

11.3 Request for Observer Status by Palestine (WT/GC/M/182)

11.3. At the March meeting, the General Council agreed to grant Palestine Observer Status at MC12 on an ad hoc basis.

11.4 Launch of the MC12 Logo – Statement by Kazakhstan (WT/GC/M/182)

11.4. At the March meeting, the representative of Kazakhstan launched the logo of the Twelfth Session of the Ministerial Conference, as part of the preparations for MC12. The Chair and the representative of Kazakhstan spoke. The General Council took note of the statements.

11.5 Date and Venue (WT/GC/M/184; WT/GC/M/186; WT/GC/M/187 and WT/GC/M/188)

11.5. At the May meeting, the Chair reported on the consultations the Director-General and he had conducted in light of the postponement of MC12 in Nur-Sultan on 8-11 June 2020 due to the COVID-19 pandemic and further to the communication Kazakhstan had circulated in document WT/GC/209 confirming that it remained ready to host MC12 in June 2021 in Nur-Sultan. The representatives of Thailand; Botswana (African Group); Jamaica (ACP); Paraguay; Brazil; Viet Nam (ASEAN); the Republic of Korea; Hong Kong, China; Barbados; Tanzania; the Russian Federation; the Dominican Republic; India; Chinese Taipei; Ecuador; Cameroon; the European Union; Nigeria; Afghanistan; Singapore and Kazakhstan spoke. During their respective interventions, Thailand; Jamaica (ACP); Paraguay; Viet Nam (ASEAN); Tanzania; Ecuador and Afghanistan referred to both items 4 and 5 of the May GC agenda²⁹ and Viet Nam (ASEAN) also referred to item 2 of the May GC agenda.³⁰ The General Council took note of the Chair's report and of the statements.

11.6. At the July meeting, the Chair reported that concerns on uncertainties brought about by the evolution of the COVID-19 pandemic had remained and that several delegations remained of the view that any date set would necessarily need to be considered as a "working hypothesis". Therefore, the third week of June 2021 – 21 to 24 June – remained as a "working hypothesis", and the General Council would take a formal decision at the appropriate time. The representatives of Brazil; Thailand; Afghanistan; Paraguay; Namibia; Viet Nam (ASEAN); the Republic of Korea; India; the United Kingdom; Botswana (African Group); Peru; South Africa; the Russian Federation; Burkina Faso (C-4); Cambodia; the European Union; Nigeria; Jamaica; Japan; Cameroon; Ecuador and Kazakhstan spoke. The General Council took note of the Chair's report and of the statements.

11.7. At the October meeting, the Chair noted that, given the uncertainties caused by COVID-19, the "working hypothesis" continued to be that the Conference would take place in the third week of June 2021 – specifically from 21 to 24 June. He invited all Members to stay constructively engaged on the matter so that the General Council could take a formal decision as soon as feasible. The representatives of Brazil; Botswana (African Group); the Dominican Republic; the United Kingdom; Namibia; South Africa; Viet Nam (ASEAN); the Russian Federation; the Philippines; India; Afghanistan; Malaysia; Chad (LDCs) and Kazakhstan spoke. The General Council took note of the Chair's report and of the statements.

11.8. At the December meeting, the Chair noted that, since the October meeting, he had continued his consultations with delegations including with group coordinators. Based on those discussions, the sense he was hearing from Members was that, in light of the current situation, it was no longer realistic to envisage a June date for MC12 and that it would be necessary to consider alternative dates towards the end of 2021. At the same time, and on the basis of what he had heard from Members, in his view, it was becoming increasingly important and urgent that a firm decision was taken so that Members would have clarity on the matter. The representatives of Thailand; Botswana (African Group); Namibia; Singapore; Barbados; Mongolia; Jamaica (ACP); Guyana (CARICOM); Australia; the United States; Malaysia; Colombia; the Russian Federation; the Republic of Korea; India; Hong Kong, China; the United Kingdom; Turkey; South Africa; Tunisia; Ecuador; the Philippines; Brazil; Chinese Taipei; Japan; Nigeria; Cambodia; Afghanistan; Uruguay; Mexico; Chad; the Kingdom of Saudi Arabia; Indonesia; Haiti; the Republic of Moldova and Kazakhstan spoke. The General Council took note of the Chair's report and of the statements.

12 PROCEDURES TO STRENGTHEN THE NEGOTIATING FUNCTION OF THE WTO – STATEMENT BY THE UNITED STATES (WT/GC/M/182; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)

12.1. At the March meeting, the United States introduced the item including the communications in documents WT/GC/W/757/Rev.1 and WT/GC/W/764/Rev.1. The representatives of the European Union; Australia; Colombia; China; Chad (LDCs); Barbados; India; Saint Lucia (OECS); South Africa; Indonesia; Jamaica (ACP); Thailand; Sri Lanka and Namibia spoke. The United States again took the floor. The General Council took note of the statements.

12.2. At the July meeting, the United States made a statement on this matter referring to its communications in documents WT/GC/W/757/Rev.1 and WT/GC/W/764/Rev.1. The representatives of Brazil; China; Australia; the European Union; Chad (LDCs); India; Colombia; the Russian Federation; South Africa; Jamaica (ACP); Japan; Turkey; Mexico and Cameroon spoke. The United States again took the floor. The General Council took note of the statements.

12.3. At the October meeting, the United States made a statement under this item referring to its communications in documents WT/GC/W/757/Rev.1 and WT/GC/W/764/Rev.1. The representatives of Brazil; the European Union; the Russian Federation; Botswana (African Group); South Africa; Saint Lucia (CARICOM); Australia; Namibia; Chad (LDCs); Norway; China; Jamaica (ACP); Indonesia; Barbados; Japan; India; Turkey and Pakistan spoke. The United States again took the floor. The General Council took note of the statements.

12.4. At the December meeting, the United States made a statement and referred to its communications in WT/GC/W/757/Rev.1 and WT/GC/W/764/Rev.1. The representatives of Botswana (African Group); China; India; the European Union; Chad (LDCs); Japan; Pakistan; Jamaica (ACP); Guyana (CARICOM); Barbados; Brazil and South Africa spoke. The United States again took the floor. The General Council took note of the statements.

13 STRENGTHENING THE WTO TO PROMOTE DEVELOPMENT AND INCLUSIVITY – COMMUNICATION FROM THE AFRICAN GROUP, CUBA, AND INDIA (WT/GC/M/188)

13.1. At the December meeting, the representative of South Africa introduced the revised communication in document WT/GC/W/778/Rev.3, co-sponsored by the African Group, Cuba and India. The representatives of Botswana (African Group); Cuba; Chad (LDCs); Oman; Jamaica (ACP); the European Union; the United States; China; Pakistan; Bangladesh; Sri Lanka and India spoke. During its intervention, the representative of Oman referred to items 11 and 12 of the December GC agenda.³¹ The General Council took note of the statements.

14 PROCEDURAL GUIDELINES FOR WTO COUNCILS AND COMMITTEES ADDRESSING TRADE CONCERNS – COMMUNICATION FROM AND STATEMENT BY CO-SPONSORS (WT/GC/M/182; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)

14.1. At the March meeting, the representative of the European Union, on behalf of the co-sponsors, introduced the revised proposal in document WT/GC/W/777/Rev.5. The representatives of Canada; China; Hong Kong, China; Switzerland; Chinese Taipei; Chad (LDCs); the United Kingdom; Bangladesh; Paraguay; the United States; India; Indonesia; South Africa and Ecuador spoke. The European Union again took the floor. The General Council took note of the statements.

14.2. At the July meeting, the representative of the European Union, on behalf of the co-sponsors, made a statement on the revised proposal in document WT/GC/W/777/Rev.5. The representatives of Norway; Uruguay; the United States; India; Brazil; Chad (LDCs); Turkey; Chinese Taipei; Hong Kong, China; Nigeria; South Africa; Bangladesh and Mexico spoke. The European Union again took the floor. The General Council took note of the statements.

14.3. At the October meeting, the representative of the European Union, on behalf of the co-sponsors, made a statement on the revised proposal in document WT/GC/W/777/Rev.5. The representatives of India; South Africa; the United Kingdom; Chad (LDCs); Mexico; Indonesia; Thailand; Bangladesh and Chinese Taipei spoke. The European Union again took the floor. The General Council took note of the statements.

14.4. At the December³² meeting, the representative of the European Union, on behalf of the co-sponsors, noted that they would continue engaging with Members on their questions on the proposal in WT/GC/W/777/Rev.5, and that they intended to report back at the next opportunity. The General Council took note of the statement.

15 THE IMPORTANCE OF MARKET-ORIENTED CONDITIONS TO THE WORLD TRADING SYSTEM – COMMUNICATION FROM THE UNITED STATES AND JOINT STATEMENT BY BRAZIL, JAPAN AND THE UNITED STATES (WT/GC/M/182; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)

15.1. At the March meeting, the representative of the United States introduced the item including its communication in document WT/GC/W/796. The representatives of Canada; Japan; Brazil; Colombia; Chinese Taipei; Nigeria; Australia; the European Union; South Africa; Uruguay; Indonesia; the United Kingdom; Norway; Pakistan; the Russian Federation; Sri Lanka; India; Mexico; Switzerland and China spoke. The United States and China again took the floor. The General Council took note of the statements.

15.2. At the July meeting³², the representatives of the United States and Brazil presented their Joint Statement on the "Importance of Market-Oriented Conditions to the World Trading System" circulated in document WT/GC/W/803. The representatives of China; Australia; Nigeria; the European Union; Norway; Switzerland; the United Kingdom; the Russian Federation; Chinese Taipei; Paraguay; South Africa; Canada; India; Japan and Burkina Faso spoke. The United States and Brazil again took the floor. The General Council took note of the statements.

During its intervention, the representative of Indonesia referred to items 10, 11 and 12 of the December GC agenda.³³ The United States again took the floor. The General Council took note of the statements.

16 UNITED STATES TRADE REPRESENTATIVE REPORT ON THE APPELLATE BODY OF THE WORLD TRADE ORGANIZATION – STATEMENT BY THE UNITED STATES (WT/GC/M/182)

16.1. At the March meeting, the representative of the United States introduced the item. The representatives of Chad (LDCs); Canada; Benin; Thailand; the Philippines; China; Argentina; the European Union; India; Barbados; Switzerland; Jamaica (ACP); the Russian Federation; Japan; Botswana (African Group); South Africa; Australia; Mexico and Indonesia spoke. The General Council took note of the statements.

17 KAZAKHSTAN – BORDER RESTRICTIONS OF GOODS IN TRANSIT – REQUEST FROM THE KYRGYZ REPUBLIC (WT/GC/M/182)

17.1. At the March meeting, the representative of the Kyrgyz Republic introduced the item including its communication in document G/C/W/774 – G/TFA/W/20 and G/C/W/774/Add.1 – G/TFA/W/20/Add.1. The representative of Kazakhstan spoke. The representatives of the Kyrgyz Republic and Kazakhstan took the floor again. The representatives of Japan and the Republic of Moldova spoke. The General Council took note of the statements.

18 TRADE RELATED CHALLENGES OF THE LEAST DEVELOPED COUNTRIES AND WAY FORWARD: A DRAFT FOR MC DECISION – COMMUNICATIONS FROM CHAD ON BEHALF OF THE LDC GROUP (WT/GC/M/188)

Singapore again took the floor. The General Council took note of the statements.

20 G20 SAUDI ARABIA 2020 – STATEMENTS BY THE KINGDOM OF SAUDI ARABIA

20.1 Trade and Investment Ministerial Meeting (WT/GC/M/187)

20.1. At the October³⁵ meeting, the representative of the Kingdom of Saudi Arabia presented the Communiqué from the G20 Trade and Investment Ministerial Meeting circulated in document WT/GC/221. The General Council took note of the statement.

20.2 G20 Leaders' Declaration – Riyadh Summit (WT/GC/M/188)

20.2. At the December³⁶ meeting, the representative of the Kingdom of Saudi Arabia presented the G20 Leaders' Declaration – Riyadh Summit circulated in document WT/L/1101. The representative of Japan spoke. The General Council took note of the statements.

21 ORIGIN MARKING REQUIREMENTS BY THE UNITED STATES – STATEMENT BY HONG KONG, CHINA (WT/GC/M/187)

At the October³⁷ meeting, the representative of Hong Kong, China raised concerns on the "Origin Marking Requirement by the United States" – a revised requirement from the United States for all goods produced in Hong Kong, China and destined to the United States be marked to indicate "China" as their origin. The representative of the United States spoke. The General Council took note of the statements.

22 INTERNATIONAL YEAR OF THE CREATIVE ECONOMY FOR SUSTAINABLE DEVELOPMENT 2021 – STATEMENT BY OMAN (WT/GC/M/188)

22.1. At the December³⁸ meeting, the representative of Oman made a statement on this matter encouraging the WTO to work together with other international organizations to support the revival of the Creative Industries. The representative of Colombia spoke. The General Council took note of the statements.

23 WTO VIRTUAL MEETINGS – STATEMENT BY OMAN (WT/GC/M/188)

23.1. At the December³⁹ meeting, the representative of Oman made a statement on this matter including a suggestion to start a conversation on the challenges and benefits of virtual meetings. The General Council took note of the statement.

24.1 Reports and Recommendations (WT/GC/M/186; WT/GC/M/187 and WT/GC/M/188)

24.1. At the July meeting, the CBFA Chairman introduced the report of the CBFA in document WT/BFA/185/Rev.1 including the Committee's recommendations. The General Council took note of the CBFA Chairman's statement, approved the Budget Committee's specific recommendation in paragraph 7.19 of WT/BFA/185/Rev.1, and adopted the report.

24.2. At the October meeting, the CBFA Chairman introduced the reports of the CBFA in documents WT/BFA/186, WT/BFA/187 and WT/BFA/188 including the Committee's recommendations. The General Council approved the Budget Committee's specific recommendations in paragraph 2.49 of WT/BFA/188 concerning transfers between budgetary sections and the WTO Audited Financial Statements for the year ended 31 December 2019 and in paragraph 4.3 of WT/BFA/188 concerning the budgetary surplus; took note of the CBFA Chairman's statement concerning the WTO budget proposal; approved paragraph 5.5 of WT/BFA/188 concerning the suspension of Administrative Measures for Niger; adopted the reports in WT/BFA/186, WT/BFA/187 and WT/BFA/188 and took note of the statements. The representatives of India and Chad (LDCs) spoke. At its request, the statement of the delegation of Niger under this agenda item was incorporated in the Minutes of the October General Council meeting. The General Council took note of the statements.⁴⁰

24.3. At the December meeting, the CBFA Chairman introduced the reports of the CBFA in documents WT/BFA/189, WT/BFA/190 and WT/BFA/191 including the Committee's recommendations. The General Council approved the Budget Committee's specific recommendation in paragraph 4.15 of WT/BFA/191 concerning the ITC 2021 Budget Proposal; approved the specific recommendation in paragraph 5.23 of WT/BFA/191 concerning the WTO 2021 Budget Proposal; took note of the CBFA Chairman's statement and adopted the reports in WT/BFA/189, WT/BFA/190 and WT/BFA/191.⁴¹

25 WTO PENSION PLAN

25.1 Election of Chairperson, Members, and Alternates to the Management Board (WT/GC/M/186)

25.1. Article 4(a) of the Regulations of the WTO Pension Plan provides, *inter alia*, for the election by the General Council of a Chairperson, four members and four alternates to the Management Board of the Pension Plan, each for a three-year term.

25.2. At the July meeting, the Chair recalled that the term of office of the current membership of the Management Board had been due for renewal and that a process of consultations had been undertaken regarding this which was announced through communications sent to delegations in May, June and July. On the basis of this process, the Chair suggested that the slate of candidates in document WT/GC/W/801 be elected to the Management Board. The General Council so agreed. The decision was subsequently circulated in WT/L/1092.

25.2 Reports (WT/GC/M/187)

25.3. At the October meeting, the Chairman of the WTOPP Management Board presented to the General Council the 2019 Report of the External Auditor and the 2019 Annual Report of the World Trade Organization Pension Plan which could be found in documents WT/L/1093 and WT/L/1094. The General Council took note of the reports and of the WTOPP Management Board Chairman's statement.

26 ADMINISTRATIVE MEASURES FOR MEMBERS IN ARREARS (WT/GC/M/182; WT/GC/M/184; WT/GC/M/186; WT/GC/M/187 AND WT/GC/M/188)

26.1. In October 2012, the General Council approved a recommendation from the Committee on Budget, Finance and Administration regarding revised Administrative Measures for Members in arrears, as contained in WT/BFA/132, Annex I. These new revised Measures entered into force on 1 January 2013. These Measures required that at the end of each meeting of the General Council, the Chairperson of the Committee on Budget, Finance and Administration should provide information with regard to which Members and Observers were under Administrative Measures; and, the General Council Chairperson would request Members and Observers in Categories II and III to inform the Secretariat as to when the payment of arrears might be expected.

26.2. At the General Council meetings in March, May, July, October, and December⁴², the Chairman of the Committee on Budget, Finance and Administration provided information with regard to which Members were under Administrative Measures and the Chair made the said request to Members and Observers in Categories II and III. The representative of the United States spoke at the July meeting. The representative of Cuba spoke at the October and December meetings. The General Council took note of the statements.

27 REVIEW OF WTO ACTIVITIES (WT/GC/M/188)

27.1. At the December meeting, the General Council considered Annual Reports for 2020 from WTO bodies that had been drawn up in pursuance of the Decision concerning procedures for an annual overview of WTO activities and for reporting under the WTO in document WT/L/105.

27.2. The General Council took note of the Chair's statement, adopted the report of the Committee on Trade and Development in document WT/COMTD/100 and took note of the reports of other WTO bodies, including the reports of the bodies under the Plurilateral Trade Agreements, in documents WT/DSB/81, WT/TPR/452, G/L/1381, S/C/60, IP/C/87, G/L/1380, WT/CTE/27, WT/BOP/R/118, WT/BFA/192, WT/REG/31, WT/WGTTT/22, GPA/AR/3, and WT/L/1100 – TCA/16.

27.3. The General Council then adopted the draft Annual Report for 2020 of the General Council (WT/GC/W/809), on the understanding that the Secretariat would make the necessary adjustments to include matters considered at that meeting.

28 APPOINTMENT OF THE NEXT DIRECTOR-GENERAL (WT/GC/M/184; WT/GC/M/185; WT/GC/M/186 AND WT/GC/M/188)

28.1. At the May meeting, the Chair said that following the announcement made by the Director-General on 14 May that he would step down on 31 August 2020, after consulting with Members and in accordance with the relevant Procedures for the Appointment of Directors-General adopted by the General Council in 2002 (WT/L/509), he initiated the process for the appointment of a new Director-General. In this regard, in line with the Procedures, the Chair had formally notified Members (JOB/GC/230) of the start of the process. Phase One would involve the nomination period; Phase Two would provide candidates the opportunity to present themselves to Members and Phase Three would be devoted to selecting and appointing one of the candidates through consultations with Members. In this Phase, in line with the Procedures, the General Council Chair would be assisted by the Chairpersons of the Dispute Settlement Body and the Trade Policy Review Body. As for the duration of Phase Two and Phase Three, he noted that, in line with Paragraph 23 of the Procedures, in the event of a vacancy in the post, the General Council Chair could establish expedited deadlines in consultation with Members as necessary. He would be consulting with Members on the matter with a view to establishing expedited deadlines. The representatives of Botswana (African Group); Mongolia (Asian Group of Developing Countries); Brazil; the Dominican Republic; Chinese Taipei; Cameroon; Turkey; Zimbabwe; Saint Lucia (CARICOM); Chad (LDCs); India; Canada; Egypt; Nigeria; Cambodia; South Africa; the European Union; the United Kingdom and Tunisia spoke. During their respective interventions, the representatives of Turkey; Cambodia; South Africa and

Tunisia referred to both items 4 and 5 of the May GC agenda.⁴³ The General Council took note of the Chair's report and of the statements.

28.2. At the General Council meeting with the candidates on 15-17 July, the Chair recalled that the nomination period had closed on 8 July and a consolidated list⁴⁴ of candidates had been circulated on 9 July. Pursuant to paragraph 14 of the Procedures in WT/L/509, Members then met formally⁴⁵ with each of the eight candidates nominated⁴⁶ for the post of the next Director-General, on the basis of modalities for the conduct of the meeting communicated to all delegations on 1 and 10 July which were recalled by the Chair at the beginning of the meeting.

28.3. At the July meeting, the Chair noted that, further to the consultations undertaken on expediting deadlines, the duration of Phase Two – period for the candidates to make themselves known to Members – could be shortened from three to two months. On that basis, Phase Three – period of consultations to narrow the field of candidates and ultimately to arrive at its choice for appointment – would start on 7 September. He gave an overview of how Phase Three was organised in the previous appointment process in 2013 and highlighted a number of elements, in particular the number of rounds of consultations that took place; the number of candidates that remained at the end of each round; the question asked and the modalities for the consultations. He in consultation with the Facilitators would be engaging with Members, including through an open-ended Informal Meeting, with the intention that before the end of the month, the modalities for the organization and conduct of Phase Three would be known to all Members and all candidates.⁴⁷ The representatives of the Philippines, the United Kingdom, Nigeria, India, Kenya, Botswana (African Group), Indonesia, Haiti, South Africa, Brazil, Egypt, Chad (LDCs) and Jamaica spoke. During their respective interventions, the representatives of Cambodia, Paraguay, Viet Nam (ASEAN), Malaysia, Peru and Cameroon referred to both items 5 and 6 of the July GC agenda.⁴⁸ The General Council took note of the Chair's report and of the statements.

28.4. At the December⁴⁹ meeting, the Chair recalled that his reports on the outcomes of the three rounds of consultations that he, together with the Facilitators, had undertaken in the context of the Process of Appointment of the next Director-General were contained in JOB/GC/244, JOB/GC/245 and JOB/GC/247. In a further communication that he had circulated on 6 November 2020 in JOB/GC/248, he had indicated that it had come to his attention that, for reasons including the health situation and current events, delegations had not been in a position to take a formal decision on 9 November. He had postponed the Special General Council meeting that had been convened for 9 November until further notice during which period he would continue to undertake consultations with delegations. The situation had not changed since then. He noted that he intended to continue consultations with a view to a formal decision being taken in accordance with the agreed rules and procedures as soon as possible early in the new year. The General Council took note of the Chair's statement.

29 DESIGNATION OF ACTING DIRECTOR-GENERAL (WT/GC/M/186)

29.1. At the July meeting, the Chair recalled that Paragraph 23 of the Procedures in WT/L/509 established that "in the event of a vacancy in the post of Director-General, the General Council shall designate one of the existing Deputy Directors-General to serve as Acting Director-General, until the appointment of a new Director-General". With the outgoing Director-General leaving at the end of August, the position of Director-General would be vacant as of 1 September. According to the Procedures, therefore, the General Council would need to designate an Acting Director-General until the new Director-General was appointed. As the consultations were still ongoing, the Chair suspended the consideration of the item with a view to resuming the discussion at the appropriate time. The General Council was reconvened on 31 July where, based on his consultations with Members, the Chair proposed that Members proceeded according to an understanding containing a number of common elements which applied and would apply however they resolved the matter. Those were:

- a. "This understanding applies for the period between 1st September 2020 and the date of formal appointment of the new Director-General.
- b. No structural changes will be made to the Secretariat during this period.
- c. All four Deputy Directors-General will continue to fully discharge their existing responsibilities in respect of administration within the Secretariat; engaging with external constituencies/stakeholders as currently; and overseeing their respective parts of the Secretariat in respect of serving Members' regular work and areas of negotiation as appropriate. They will also continue to maintain close contact with each other in the exercise of their respective responsibilities on behalf of the organization.
- d. And, reflecting the existing and appropriate boundaries of governance, the Deputy Directors-General will undertake these responsibilities in close consultation with Members, where relevant, as represented by the General Council Chair."

29.2. The General Council so agreed. The Director-General and the Chair then spoke. The General Council took note of the statements.

30 APPOINTMENT OF OFFICERS TO WTO BODIES (WT/GC/M/182; WT/GC/M/184 AND WT/GC/M/188)

30.1. At the March meeting, the Chair recalled that in accordance with the Guidelines for Appointment of Officers to WTO Bodies approved by the General Council in 2002 (WT/L/510), and the related practical steps to improve their implementation (JOB/GC/22), she, together with the Chairman of the Dispute Settlement Body, Ambassador David Walker (New Zealand), had conducted consultations on a slate of names for the appointment of Chairpersons to WTO regular bodies listed in Groups 1, 2, 4 and 5 in the Annex to the Guidelines. The process had included an Informal General Council meeting which had been held on 21 February where she had shared with delegations a partial slate of names where there appeared to be consensus – those had been for the General Council; the DSB; the TPRB; the Goods, Services and TRIPS Councils; and the Working Groups on Trade, Debt and Finance and Trade and Transfer of Technology. She had also noted that, for the other bodies, consultations had still been ongoing with the respective groups to finalise the slate and that she had been confident that a solution was within reach. Those consultations had continued until that morning, and as a result, they were in a position that day to present a complete slate of names for the General Council's consideration.

30.2. On the basis of the consultations, there was consensus on the following slate of names:

30.3. On behalf of the Chairpersons of the CTG and CTS, the Chair also made a statement on the consultations on the Chairmanships of the subsidiary bodies of the two Councils in accordance with the relevant guidelines. The United States spoke. The General Council took note of the statements.

30.4. At the May⁵⁰ meeting, the Chair announced that he would begin consultations on the Appointment of a new CoA SS Chairperson given the impending departure of Ambassador Deep Ford. The General Council took note of the Chair's statement.

30.5. At the December meeting, the Chair said that in accordance with the Guidelines for the Appointment of Officers to WTO bodies in document WT/L/510 and the practical steps to improve the implementation of the Guidelines (JOB/GC/22), he would be starting the selection process for the appointment of chairpersons to the WTO bodies in Groups 1, 2, 4 and 5 of the Annex to the Guidelines. In accordance with paragraph 7.1(b) of the Guidelines, he would be assisted in the selection process by the serving Chair of the Dispute Settlement Body, Ambassador Dacio Castillo

31 ELECTION OF CHAIRPERSON (WT/GC/M/182)

31.1. At the March meeting, the Chair, as the outgoing presiding officer of the General Council, made a statement. The General Council then unanimously elected H.E. Dr David Walker (New Zealand) to the Chair.

31.2. The Director-General and the newly-elected Chair spoke. The General Council took note of the statements. The representatives of Chad (LDCs); Seychelles; Benin; Jamaica (ACP) and the Philippines (ASEAN) spoke. The General Council took note of the statements.
