RÉSUMÉ DES RESTRICTIONS À L'EXPORTATION ET DES MESURES D'ASSOUPLISSEMENT DES ÉCHANGES EN RAPPORT AVEC LA PANDÉMIE DE COVID-19

RAPPORT DU SECRÉTARIAT¹

1 INTRODUCTION

1. À sa réunion des 30 et 31 mars 2022, le Comité a demandé au Secrétariat d'établir une troisième révision du rapport résumant les restrictions à l'exportation et les mesures d'assouplissement² des échanges adoptées par les Membres en rapport avec la pandémie de COVID-19.
2. Le présent rapport recense et résume les renseignements pertinents sur les prohibitions et restrictions à l'exportation qui ont été notifiées par les Membres au titre de la Décision de 2012 sur les procédures de notification des restrictions quantitatives³ (la Décision), les communications contenant des renseignements sur les mesures d'assouplissement des échanges notifiées au Comité par les Membres, ainsi que d'autres mesures prises par les Membres de l'OMC et recensées dans le cadre de l'exercice de suivi du commerce sous l'intitulé "*COVID-19: mesures affectant le commerce des marchandises*".⁴
3. La présente révision tient compte de tous les renseignements disponibles au 12 octobre 2022. Les annexes 1 et 2 donnent respectivement un aperçu des principaux éléments concernant les restrictions et prohibitions à l'exportation, et les mesures d'assouplissement des échanges. En outre, la liste complète des notifications et communications qui ont été présentées au Comité et analysées dans le présent rapport figure dans le document G/MA/W/157/Rev.5.

2 PROHIBITIONS ET RESTRICTIONS À L'EXPORTATION

4. Au 12 octobre 2022, un total de 98 mesures prohibant ou restreignant les exportations en raison de la pandémie de COVID-19 avaient été adoptées par les Membres et avaient été soit notifiées formellement en tant que restriction quantitative soit enregistrées dans le cadre de l'exercice de suivi du commerce de l'OMC. Le nombre de mesures est inchangé depuis la dernière révision du présent rapport, les seuls changements étant que quatre mesures ont été supprimées et une a été modifiée. Parmi ces mesures, 68 ont été notifiées par 35 Membres au Comité de l'accès aux marchés au titre de la Décision.⁵ D'après l'exercice de suivi du commerce, 19 Membres ont introduit 30 mesures additionnelles. À la date du présent rapport, ces mesures n'ont pas été notifiées au titre de la Décision.

5. L'annexe 1 donne un aperçu des différents éléments concernant ces prohibitions et restrictions à l'exportation. En vue de faciliter l'analyse de ces mesures et d'en permettre la comparaison, certains éléments ont été uniformisés (par exemple le type de mesure, les produits visés, la justification au



regard de l'OMC, etc.). Aux fins du présent rapport, une mesure est comptée séparément chaque fois qu'elle peut être distinguée clairement d'une autre mesure (par exemple s'il existe deux instruments juridiques nationaux clairement distincts). Aucune prorogation, modification ou suppression de la mesure initiale n'a été comptabilisée comme une nouvelle mesure. Les notifications de restrictions quantitatives sont présentées selon un format structuré et, dans la plupart des cas, les renseignements qu'elles contiennent peuvent donc être comparés. Cela est un peu moins vrai pour les renseignements issus de l'exercice de suivi du commerce et, par conséquent, la définition des mesures provenant de cette source peut varier pour ce qui est de la portée ainsi que des renseignements concernant les modifications et les prorogations.

2.1 Types de mesures

6. La majorité des 98 mesures de restriction à l'exportation qui ont été prises par les Membres en réponse à la COVID-19 ont pris la forme d'interdictions ou de prohibitions complètes (36%), suivies par des restrictions à l'exportation sous la forme de licences d'exportation non automatiques (18%) et de prohibitions conditionnelles (15%)⁶. Les restrictions à l'exportation mentionnées dans le contexte de l'exercice de suivi du commerce, pour lesquelles il n'y a pas de catégories normalisées de mesures, représentent 29% de l'ensemble des mesures. Deux mesures prennent la forme d'un contingent global pour les exportations. Voir le graphique 1.

Graphique 1 – Prohibitions ou restrictions à l'exportation en réponse à la COVID-19, par type de mesure (pourcentage)





2.2 Chronologie des mesures prises

7. La grande majorité des mesures de prohibition et de restriction à l'exportation ont été prises par les Membres entre janvier et avril 2020 (67 des 98 mesures), ce qui coïncide avec la déclaration de l'état de pandémie faite par l'Organisation mondiale de la santé (11 mars 2020), et les confinements et autres mesures sanitaires ultérieurs imposés par les Membres en réponse à la COVID-19. Il semblerait que seules 14 nouvelles mesures de restriction des exportations ont été prises depuis juillet 2020. Pour 10 mesures, soit il n'y a pas d'information sur la date d'entrée en vigueur, soit il y a plusieurs dates indiquant le début de la mesure. Voir le graphique 2.

Graphique 2 – Prohibitions ou restrictions à l'exportation en réponse à la COVID-19, chronologie des mesures prises



2.3 Durée des mesures

8. Une grande partie des mesures de restriction à l'exportation adoptées par les Membres ne contiennent pas de renseignements complets concernant leur durée. Pour 29 des 98 mesures de l'ensemble de données, aucune indication n'est fournie concernant la durée prévue ou le Membre concerné n'a présenté aucune communication ultérieure confirmant que la mesure avait expiré ou avait été supprimée. Pour les 69 mesures au sujet desquelles des renseignements sont disponibles, la majorité des restrictions ont été en place pendant moins de 90 jours (soit moins de 3 mois), et 16 mesures ont été en place entre 181 et 270 jours. 2.4 Chronologie du nombre de mesures en vigueur, par date

9. Sur la base des renseignements concernant les dates auxquelles les mesures ont été prises (section 2.2) et leur durée (section 2.3), il est possible de suivre le nombre de mesures qui étaient en vigueur à une date donnée et leur évolution. Les renseignements disponibles donnent à penser qu'à la fin du mois d'avril 2020, environ deux mois après que l'OMS a déclaré la pandémie, 71 mesures de restriction à l'exportation avaient été mises en place, un nombre qui a régulièrement

diminué depuis. En octobre 2022, presque trois ans après le début de la pandémie, il semble que 27 mesures de restriction à l'exportation restaient en vigueur. Voir le graphique 4.

Graphique 4 – Prohibitions ou restrictions à l'exportation en réponse à la COVID-19, statut actuel des mesures



2.5 Produits visés

10. Compte tenu du type de produits visés par les mesures, on peut observer un léger changement au cours de la pandémie. La pandémie de COVID-19 n'a plus été mentionnée comme étant la raison des restrictions visant les produits alimentaires en 2022, et les mesures concernant les équipements de protection individuelle ainsi que les antiseptiques et désinfectants semblent jouer un rôle plus modeste à ce stade. Toutefois, il apparaît que certains produits – tels que les dispositifs et équipements médicaux, d'autres fournitures médicales, les trousse d'essai et les vaccins contre la COVID-19 – sont presque soumis aux mêmes restrictions qu'au cours du premier semestre de 2020. Cela donne à penser qu'il y a des pénuries mondiales persistantes de ces produits.

Graphique 5 – Prohibitions ou restrictions à l'exportation en réponse à la COVID-19, par produits visés



2.6 Justifications citées au regard de l'OMC

11. Pour les restrictions et prohibitions à l'exportation qui ont été notifiées au titre de la Décision, les Membres ont fourni des renseignements concernant leur justification au regard des règles de l'OMC. Les Membres ont justifié l'introduction de près de la moitié des 98 mesures de restriction quantitative notifiées au titre des articles XI:2 a) et XX b) du GATT de 1994, qui concernent, respectivement, les prohibitions ou restrictions à l'exportation appliquées temporairement pour prévenir une situation critique due à une pénurie de produits alimentaires ou d'autres produits essentiels pour la partie exportatrice, ou pour remédier à cette situation, et les mesures nécessaires à la protection de la santé des personnes et des animaux ou à la préservation des végétaux. Les Membres ont exclusivement cité l'article XI:2 a) du GATT de 1994 pour 16% des mesures. D'autres objectifs de politique ont été mentionnés dans les autres cas, y compris la protection de la santé et de la vie des personnes ou la protection des intérêts essentiels de sécurité, ont été cités sans mentionner de disposition spécifique de l'OMC, ou aucune justification n'a été fournie. On ne dispose d'aucun renseignement de ce type pour les 30 mesures recensées dans le cadre de l'exercice de suivi du commerce. Voir le graphique 6.

Graphique 6 – Prohibitions ou restrictions à l'exportation en réponse à la COVID-19, par justification citée au regard de l'OMC



2.7 Statut actuel des mesures

12. Sur la base des renseignements disponibles, on a pu observer un léger recul des mesures en vigueur en octobre 2022 par rapport à octobre 2021, lorsque la précédente version du présent rapport a été publiée. Cependant, près d'un tiers des prohibitions et restrictions à l'exportation (27%), tant celles notifiées en tant que restrictions quantitatives que celles recensées dans le cadre de l'exercice de suivi du commerce, étaient encore en vigueur en octobre 2022. Les autres mesures ont expiré comme indiqué initialement (41%) ou bien le Membre a présenté une notification pour informer les autres Membres que la mesure avait été supprimée (32%). 3 MESURES D'ASSOUPLISSEMENT DES ÉCHANGES

13. L'annexe 2 contient un résumé de la teneur de toutes les communications concernant les mesures d'assouplissement des échanges qui ont été prises par les Membres en réponse à la COVID-19 et présentées au Comité de l'accès aux marchés, ainsi que des mesures d'assouplissement des échanges recensées dans le cadre de l'exercice de suivi du commerce. Contrairement aux prohibitions et restrictions à l'exportation décrites dans la section 2, qui ont été présentées conformément à la prescription de notification découlant de la Décision, ces communications ont été présentées volontairement par les Membres à des fins de transparence.

14. Au 12 octobre 2022, 15 Membres avaient notifié au Comité de l'accès aux marchés un total de 27 communications contenant 41 mesures d'assouplissement des échanges. En vue de faciliter l'analyse, et lorsque les renseignements disponibles le permettent, certains des éléments figurant dans les communications ont été uniformisés à des fins de comparaison (par exemple les types de mesures). Les renseignements additionnels recueillis par le Secrétariat dans le cadre de l'exercice de suivi du commerce⁷ font état de 141 autres mesures d'assouplissement des échanges. De plus, 19 ont été notifiées à d'autres comités de l'OMC, par exemple le Comité de la facilitation des échanges (14 mesures), le Comité des pratiques antidumping (2 mesures), le Comité des licences d'importation (une mesure) et le Comité des obstacles techniques au commerce (une mesure). L'analyse figurant dans la présente révision englobe 14 mesures additionnelles, principalement parce qu'un ensemble de données plus complet était disponible; il ne s'agit pas nécessairement de mesures nouvelles.

3.1 Types de mesures


15. Les mesures fiscales visent à réduire le prix des importations essentielles, les rendant ainsi plus abordables et plus disponibles, représentent un peu plus des trois quarts des mesures d'assouplissement des échanges. Par exemple, plus de 50% de ces mesures limitaient, supprimaient ou suspendaient le paiement des droits de douane à l'importation de produits jugés "essentiels" pour lutter contre la pandémie de COVID-19, ou prévoyaient une exonération du paiement de ces droits (56%). En outre, plusieurs Membres ont supprimé ou suspendu le paiement d'autres taxes et/ou droits, tels que la taxe sur la valeur ajoutée, sur ces produits "essentiels", ou ont prévu une exonération du paiement de ces autres taxes et/ou droits (14%). En vue de fournir des liquidités aux importateurs, certains Membres ont également décidé de reporter le paiement des droits de douane et d'autres taxes sur tous les produits importés (6% des mesures).

16. En plus des mesures fiscales, environ 20% des mesures d'assouplissement des échanges visaient à simplifier ou à faciliter les procédures douanières, par exemple en introduisant des procédures de dédouanement simplifiées ou accélérées (6%), telles que l'établissement de circuits verts pour prioriser l'importation de produits essentiels, et la simplification ou l'élimination de certaines procédures (14%). Enfin, environ 4 % des mesures relèveraient d'autres catégories, telles

que l'établissement de procédures spéciales pour l'importation de dons (marchandises de première nécessité) ou l'engagement de s'abstenir d'imposer des prohibitions ou des restrictions à l'exportation de produits "essentiels". Voir le graphique 8.

Graphique 8 – Mesures d'assouplissement des échanges liées à la COVID-19, par types de mesures



3.2 Durée des mesures

17. La majorité des mesures d'assouplissement des échanges semblent avoir un caractère temporaire. Il convient toutefois de noter que, dans 88 cas, les renseignements relatifs à la durée prévue de la mesure sont soit incomplets soit inexistant. S'agissant des mesures pour lesquelles les Membres ont fourni des renseignements, la majorité semble avoir été en place entre 271 et 365 jours (soit entre 9 mois et 1 an), avec des mesures qui ont duré de 3 à 6 mois et d'autres ayant duré plus longtemps. La mesure la plus courte n'a duré que 9 jours, tandis que la plus longue devrait rester en place pendant 987 jours. Il convient également de mentionner que certaines mesures ont été qualifiées de mesures d'assouplissement des échanges "permanentes" pour promouvoir le commerce de produits "essentiels" dans la lutte contre la pandémie de COVID-19. Graphique 9 – Mesures d'assouplissement des échanges liées à la COVID-19, par durée des mesures



3.3 Produits visés

18. Il apparaît que les principales catégories de produits visés par les mesures d'assouplissement des échanges sont de nature semblable aux produits qui ont fait l'objet des prohibitions et restrictions à l'exportation analysées dans la section 2. Cinquante et un Membres ont pris des mesures visant à simplifier l'importation d'EPI, qui comprend les catégories des équipements de protection du visage et des yeux (par exemple les masques de protection, les écrans faciaux et les lunettes de protection), des vêtements de protection et des gants. Viennent ensuite des mesures relatives à différents types d'antiseptiques et de désinfectants, y compris différents types d'alcool utilisés dans la préparation de ces produits. Il est intéressant de noter qu'un Membre a utilisé la liste indicative de l'OMC des intrants de vaccins contre la COVID-19⁸ pour définir 14 produits admissibles au bénéfice d'une suspension tarifaire. Graphique 10 – Mesures d'assouplissement des échanges liées à la COVID-19, par types de produits (nombre de Membres)





3.4 Statut actuel

19. Sur la base des renseignements disponibles, 39% des mesures d'assouplissement des échanges semblent avoir expiré, tandis que 13% d'entre elles restent en vigueur à la date du présent rapport. Cependant, il n'y a pas d'information sur le statut actuel de près de 48% des mesures dans l'ensemble des données. Par rapport au mois d'octobre 2021, le volume total d'information s'est légèrement amélioré, mais dans le même temps le nombre de mesures toujours en vigueur semble avoir diminué.
