Elle rend compte des activités de coopération technique de l'Union européenne, ainsi que de certains de ses États membres (Allemagne; Autriche; Bulgarie; Danemark; Espagne; Estonie; Finlande; France; Hongrie; Pays-Bas; Portugal; République tchèque; Royaume-Uni; Slovaquie; et Suède).

Le présent document complète les renseignements sur la mise en œuvre de l'article 67 de l'Accord sur les ADPIC fournis dans le document IP/C/W/582/Add.7 du 2 novembre 2012.

Il concerne les activités de coopération technique menées entre juillet 2013 et août 2014 par l'Union européenne et certains de ses États membres en faveur de pays en développement et pays les moins avancés Membres, avec pour objectif de faciliter la mise en œuvre de l'Accord sur les ADPIC.

Some participants formed an informal group to take these discussions forward and to help improve the effectiveness of TMO type entities in the country.</p> <p>In-depth training and knowledge transfer on the upgraded automation systems (IPAS Java, EDMS and WIPOScan) were provided to the IPO Pakistan IT team in 2013 and 2014. In this reporting period, two sessions were held in Karachi: from 25-29 November 2013 and from 24 February-7 March 2014 respectively.</p> <p>The third planned technology training for IPO Pakistan IT team was conducted from 5-9 May 2014 in Karachi. The training was on the Oracle database management system (DBMS) focusing on the DBMS architecture, administration, performance monitoring and tuning, and Backup and Recovery mechanisms.</p> <p>Existing IPO Pakistan website would be upgraded to a comprehensive dynamic web portal which would include: online Patent Gazettes and Trademark Journals; public search of IP databases; online checking of IP application's processing status; registration and online access codes for IP Attorneys and applicants; an intranet for internal communication and information sharing between the 5 offices of IPO Pakistan located in Karachi, Lahore and Islamabad. With regard to transfer of technology, plant variety protection provides the basis for the transfer of technology (i.e. the varieties) in agriculture. Ownership of plant breeders' rights (PBR) could be shared in different ways according to the funding by the different parties of the breeding activity. PBR sets up the legal framework enhancing the relationship between researchers, PBR holders, licensees and users and facilitates dissemination of varieties to farmers.

The breeders' exemption provides also a mechanism to facilitate access to germplasm. The breeder's exemption under the UPOV Convention allows the breeder of a variety to enjoy the right of his variety whilst allowing other breeders to use the material of the protected variety for further breeding. Companies or individual breeders can use the protected varieties of other breeders freely and incorporate them into their breeding programs. If the resulting new variety is distinct, they can also exploit it freely.
