ACTIVITÉS DE COOPÉRATION TECHNIQUE: RENSEIGNEMENTS FOURNIS PAR D'AUTRES ORGANISATIONS INTERGOUVERNEMENTALES

CONSEIL DE COOPÉRATION DES ÉTATS ARABES DU GOLFE

À sa réunion des 14-15 juin 2023, le Conseil des ADPIC est convenu d'inviter les observateurs des organisations intergouvernementales auprès du Conseil à mettre à jour les renseignements fournis sur leurs activités de coopération technique et financière en rapport avec la mise en œuvre de l'Accord sur les ADPIC.

Le présent document contient les renseignements reçus du Conseil de coopération des États arabes du Golfe (CCG) dans une communication datée du 3 septembre 2023.

Introduction

- 1. Le CCG est une organisation intergouvernementale dont les États membres sont les Émirats arabes unis, l'État du Koweït, Oman, le Qatar, le Royaume d'Arabie saoudite et le Royaume de Bahreïn.
- 2. Conformément à l'article 20 de l'Accord économique du CCG, selon lequel "les États membres élaboreront des programmes encourageant les talents et appuyant l'innovation et l'invention; collaboreront dans le domaine de la propriété intellectuelle et élaboreront des règlements et procédures garantissant la protection des droits de propriété intellectuelle; et coordonneront leurs politiques vis-à-vis des autres pays, des blocs régionaux et des organisations internationales et régionales", le Secrétariat général du CCG destine la plupart de ses activités de coopération technique à ses États membres.
- 3. Le présent document contient un rapport concernant les principales activités de coopération technique organisées par le Secrétariat général du CCG Office des brevets du CCG, seul ou en coopération avec d'autres parties, entre le 1^{er} septembre 2022 et le 1^{er} septembre 2023 et qui ont un lien avec la propriété intellectuelle, suite à l'invitation de la Présidence du Conseil des ADPIC de l'OMC à fournir des renseignements actualisés sur ces activités.

Les activités d'assistance technique organisées par le Secrétariat général du CCG ou en coopération avec d'autres parties pendant la période susmentionnée ont porté sur divers aspects concrets de la propriété intellectuelle. Ces activités ont été organisées sous la forme d'ateliers, de formations en cours d'emploi, de détachements ou d'aides à la participation à des conférences ou à des manifestations internationales sur la propriété intellectuelle.
