**PROPUESTA DE PROCEDIMIENTO PARA LA SUPRESIÓN DEL CARÁCTER
RESERVADO DE LOS DOCUMENTOS DE NEGOCIACIÓN
DE LA RONDA DE TOKIO**

APROBADA POR EL COMITÉ EL 22 DE OCTUBRE DE 2014

Los Miembros disponen de seis meses a partir de la fecha de este documento para examinar los documentos que redactaron y que se enumeran en el anexo¹ y notificar a la Secretaría todo documento que consideren que debe seguir teniendo carácter reservado durante un período adicional. La Secretaría facilitará a dichos Miembros, previa petición, las versiones electrónicas de los documentos pertinentes. Las peticiones deben dirigirse a la Secretaría en el plazo de un mes a contar desde la fecha de este documento.

En mayo de 2015 se celebrarán consultas informales abiertas para examinar un proyecto de Decisión en el que se propondría la supresión general en un futuro próximo del carácter reservado de todos los documentos enumerados en el anexo¹, así como la supresión automática en una fecha posterior del carácter reservado de los documentos respecto de los cuales las delegaciones hayan solicitado un plazo adicional de protección.

Sobre la base de esas consultas, los Miembros examinarán el proyecto de Decisión y adoptarán medidas al respecto en la reunión formal que celebrará el Comité tras las consultas de mayo de 2015.
