SUBJECT: ADVANCE AGENDA FOR THE SEVENTEENTH SESSION

WITH REFERENCE TO THE FOCINOTE ON THE FIRST PAGE OF THE ADVANCE AGENDA (L/1254) I WISH TO ADVISE THAT I HAVE RECEIVED THE FOLLOWING COMMUNICATION FROM THE GOVERNMENT OF THE NETHERLANDS:

"THE MEMBER STATES AND THE INSTITUTIONS OF THE COMMUNITY DO NOT FEEL THAT FOR THE TIME BEING THEY HAVE ANY INFORMATION TO SUBMIT UNDER ARTICLE XXIV:7(a) OF THE GENERAL AGREEMENT ON TARIFFS AND TRADE. HOWEVER, THE MEMBER STATES AND THE INSTITUTIONS OF THE COMMUNITY ARE OF OPINION THAT IT WOULD BE USEFUL TO INCLUDE IN THE AGENDA FOR THE XVIITH SESSION AN ITEM RELATING TO THE ROME TREATY. IN ORDER, IN PARTICULAR, TO GIVE THE COMMUNITY AN OPPORTUNITY TO PROVIDE, IF THE NEED SHOULD ARISE, CERTAIN INFORMATION WHICH MIGHT BE OF INTEREST TO THE COMPACTING PARTIES."
