## SUBJECT: MEETING OF THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS

- 1. THE CURRENT PROGRAMME OF MEETINGS (L/1973/Rev.1) ENVISAGES THAT THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS WILL MEET FROM 10 TO 21 JUNE 1963. IN THE LIGHT OF THE AMOUNT OF WORK TO BE ACCOMPLISHED IT WOULD APPEAR THAT A SHORTER PERIOD WOULD SUFFICE. CONSEQUENTLY, THE COMMITTEE WILL CONVENE ON WEDNESDAY, 12 JUNE AT 3 P.M. THE MEETINGS WILL BE HELD AT THE BATIMENT ELECTORAL. RUE GENERAL DUFOUR. GENEVA.
- UNDER THE ARRANGEMENTS AGREED UPON AT THE TWENTIETH SESSION THE COMMITTEE 2. SHOULD AT THIS MEETING CARRY OUT CONSULTATIONS WITH FIVE CONTRACTING PARTIES (BURMA, FINLAND, INDONESIA, ISRAEL AND TURKEY; CF. BISD, ELEVENTH SUPPLEMENT, PAGE 166). SINCE THEN, IT HAS BEEN FOUND NECESSARY TO POSTPONE THE CONSUL-TATION WITH ISRAEL UNTIL THE AUTUMN. IN ADDITION TO THE REMAINING FOUR CONSULTATIONS IT WILL BE RECALLED THAT A CONSULTATION INITIATED WITH CHILE UNDER ARTICLE XVIII:12(a) IN 1962 HAS YET TO BE COMPLETED, AND THAT THE COUNCIL HAS BEEN ASKED TO EXAMINE. BEFORE 30 JUNE 1963, THE CHILEAN REQUEST FOR A FURTHER EXTENSION OF THE WAIVER DECISION OF 27 MAY 1959 AUTHORIZING THE USE OF CERTAIN IMPORT SURCHARGES FOR BALANCE-OF-PAYMENTS REASONS (IBID. PAGE 68). IT IS PROPOSED THAT THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS, AT ITS FORTHCOMING MEETING. COMPLETE THE CONSULTATION WITH CHILE UNDER ARTICLE XVIII:12(a) AND MAKE APPROPRIATE RECOMMENDATIONS ON THE BALANCE-OF-PAYMENTS ASPECTS OF THE REQUEST FOR AN EXTENSION OF THE WAIVER, FOR CONSIDERA-TION BY THE COUNCIL AT ITS FOLLOWING MEETING.
- 3. ON THE ASSUMPTION THAT THESE PROPOSALS ARE ACCEPTABLE TO THE CONTRACTING PARTIES, THE COMMENCING DATES FOR THE CONSULTATIONS HAVE BEEN SET BY THE CHAIRMAN OF THE COMMITTEE AS FOLLOWS:
