## SUBJECT: MEETING OF ACTION COMMITTEE AND ITS SUB-COMMITTEES

IN ACCORDANCE WITH THE CURRENT PROGRAMME OF MEETINGS (L/2083), THE ACTION COMMITTEE WILL HOLD ITS NEXT MEETING ON 16 AND 17 DECEMBER. THE MEETING WILL OPEN ON 16 DECEMBER AT 10.30 A.M., AT THE PALAIS DES NATIONS, GENEVA.

AS INDICATED IN GATT/AIR/358, SUB-COMMITTEE 1 OF THE ACTION COMMITTEE WILL MEET ON 2 DECEMBER, SUB-COMMITTEE 3 WILL HOLD ITS FIRST MEETING ON MONDAY 9 DECEMBER (SEE L/2083). AS REGARDS SUB-COMMITTEE 2, FOR WHICH NO MEETING DATE HAS SO FAR BEEN FIXED BUT WHICH IS ALSO EXPECTED TO MEET PRIOR TO THE NEXT MEETING OF THE FULL COMMITTEE (AC/3, PARA.36), I PROPOSE THAT IT SHOULD MEET ON 12 DECEMBER. THE MEETINGS OF SUB-COMMITTEES 1 AND 3 WILL OPEN ON THE RESPECTIVE DATES AT 10.00 A.M.. THE MEETING OF SUB-COMMITTEE 2 WILL OPEN AT 3.00 P.M. ON 12 DECEMBER. ALL MEETINGS WILL BE HELD AT VILLA LE BOCAGE (ANNEX) GENEVA. FOR THE TERMS OF REFERENCE AND COMPOSITION OF THE THREE SUB-COMMITTEES, SEE SECTION C OF DOCUMENT AC/3.

IN PREPARATION FOR THE MEETING OF THE ACTION COMMITTEE AND ITS SUB-COMMITTEES, CONTRACTING PARTIES ARE INVITED TO INFORM THE SECRETARIAT OF THE PROGRESS THEY HAVE MADE IN IMPLEMENTING THE VARIOUS POINTS OF THE ACTION PROGRAMME. AS REGARDS THE MEETING OF SUB-COMMITTEE 2, CONTRACTING PARTIES WILL HAVE NOTED THAT A NUMBER OF PROPOSALS, FALLING WITHIN THE TERMS OF REFERENCE OF THIS SUB-COMMITTEE, WHICH WERE PUT FORWARD AT THE MINISTERIAL MEETING HAVE SO FAR NOT BEEN ELABORATED IN DETAIL AND HAVE, THEREFORE, NOT YET BEEN ACTED UPON (SEE MIN(63)7 PARA.6(a) AND (b); ALSO AC/3 PARA.33(c) AND L/2080, PAGE 1). CONTRACTING PARTIES CONCERNED ARE URGED TO SUBMIT FOR CONSIDERATION BY THE SUB-COMMITTEE AND THE ACTION COMMITTEE PAPERS SETTING OUT IN SPECIFIC TERMS POSSIBILITIES FOR IMPLEMENTING THEIR PROPOSALS.

MEMBERS OF THE ACTION COMMITTEE AND THE SUB-COMMITTEES, AS APPROPRIATE, AND ANY OTHER CONTRACTING PARTIES, ASSOCIATED GOVERNMENTS AND INTERNATIONAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS ARE REQUESTED TO ADVISE ME AT LEAST THREE DAYS IN ADVANCE OF THE RESPECTIVE MEETING DATES OF THE NAMES OF THEIR REPRESENTATIVES.
