SUBJECT: MEETINGS OF TRADE NEGOTIATIONS COMMITTEE AND SUBORDINATE BODIES

AT ITS MEETING, ON 8-10 APRIL, THE TRADE NEGOTIATIONS COMMITTEE AGREED THAT, TO MARK THE FORMAL OPENING OF THE TRADE NEGOTIATIONS ON 4 MAY 1964, A MEETING OF THE TRADE NEGOTIATIONS COMMITTEE SHOULD BE HELD AT MINISTERIAL LEVEL, STARTING AT 3 PM ON 4 MAY AND CONCLUDING IF POSSIBLE ON 5 MAY, IT BEING SUGGESTED HOWEVER THAT MINISTERS SHOULD BE PREPARED TO STAY IF NECESSARY FOR 6 MAY ALSO.

MEMBERS OF THE COMMITTEE AND OTHER CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS ARE REQUESTED TO ADVISE ME BY 27 APRIL OF THE NAMES OF THEIR MINISTERS AND OFFICIALS WHO WILL ATTEND THIS MEETING.
