## SUBJECT: MEETING OF COUNCIL OF REPRESENTATIVES, 27 MAY

THE NEXT MEETING OF THE COUNCIL WILL BE HELD AT THE INTERNATIONAL LABOUR OFFICE; GENEVA, ON WEDNESDAY 27 MAY, BEGINNING AT 10 AM.

IT IS PROPOSED THAT THE AGENDA FOR THE MEETING SHOULD INCLUDE THE FOLLOWING ITEMS:

- 1. UNITED STATES TARIFF CLASSIFICATION: REQUEST BY THE UNITED STATES GOVERNMENT FOR AN EXTENSION OF THE DECISION OF 20 JULY 1963 (L/2219).
- 2. <u>ARTICLE XV:6</u>: REQUEST BY THE CUBAN GOVERNMENT FOR WAIVER FROM THE OBLIGATION TO ACCEPT A SPECIAL EXCHANGE AGREEMENT (L/2216 AND Add.1).
- 3. <u>BALANCE-OF-PAYMENTS RESTRICTIONS</u>: REPORTS ON CONSULTATIONS WITH CEYLON, PAKISTAN AND SOUTH AFRICA.
- 4. <u>SECRETARIAT AND CONFERENCE ACCOMPANION</u>: A NOTE WILL BE DISTRIBUTED BY THE EXECUTIVE SECRETARY.
- 5. ADMINISTRATIVE AND FINANCIAL QUESTIONS:

  - (D) WORKING PARTY ON EEC/AFRICAN STATES ASSOCIATED WITH THE EEC.
