SUBJECT: APPOINTMENT OF WORKING PARTIES

AT THEIR TWENTY-FIRST SESSION THE CONTRACTING PARTIES REQUESTED THE COUNCIL TO ESTABLISH WORKING PARTIES TO EXAMINE, IN THE LIGHT OF THE RELEVANT PROVISIONS OF THE GENERAL AGREEMENT, THE PROVISIONS OF THE AGREEMENT CREATING AN ASSOCIATION BETWEEN THE EUROPEAN ECONOMIC COMMUNITY AND TURKEY AND OF THE CONVENTION OF ASSOCIATION BETWEEN THE EUROPEAN ECONOMIC COMMUNITY AND THE ASSOCIATED AFRICAN AND MALAGASY STATES. AT THE MEETING OF THE COUNCIL ON 27 MAY IT WAS AGREED THAT CONTRACTING PARTIES WISHING TO PARTICIPATE IN EITHER OR BOTH OF THESE WORKING PARTIES SHOULD SO INFORM THE SECRETARIAT IN ADVANCE OF THE NEXT MEETING OF THE COUNCIL, WHICH IS TO BE HELD ON 25 JUNE, AT WHICH MEETING THE COMPOSITION OF THE WORKING PARTIES WILL BE ESTABLISHED.

IN RESPONSE TO THE ARRANGEMENT MADE BY THE CONTRACTING PARTIES AT THE TWENTY-FIRST SESSION AND TO THE REQUESTS ISSUED IN DOCUMENTS L/2203 AND L/2204, A NUMBER OF CONTRACTING PARTIES HAVE SUBMITTED QUESTIONS CONCERNING THE PROVISIONS AND IMPLEMENTATION OF THE TWO ASSOCIATION INSTRUMENTS. ON THE BASIS OF THESE QUESTIONS TWO QUESTIONNAIRES HAVE BEEN PREPARED AND HAVE BEEN TRANSMITTED TO THE MEMBER STATES OF THE COMMUNITY AND TO THE ASSOCIATED COUNTRIES. REPLIES TO THE QUESTIONS HAVE BEEN REQUESTED BY THE END OF JULY AND WILL BE CIRCULATED TO CONTRACTING PARTIES.

OBJET: CONSTITUTION DE GROUPES DE TRAVAIL

A LEUR VINGT ET UNIEME SESSION, LES PARTIES CONTRACTANTES ONT DEMANDE AU CONSEIL D'INSTITUER DES GROUPES DE TRAVAIL EN VUE D'EXAMINER, A LA LUMIERE DES DISPOSITIONS APPROPRIEES DE L'ACCORD GENERAL, L'ACCORD CREAT UNE ASSOCIATION ENTRE LA COMMUNAUTE ECONOMIQUE EUROPEENNE ET LA TURQUIE ET LA CONVENTION D'ASSOCIATION ENTRE LA COMMUNAUTE ECONOMIQUE EUROPEENNE ET LES ETATS AFRICAINS ET MALGACHE ASSOCIES. A SA REUNION DU 27 MAI, LE CONSEIL A DECIDE QUE LES PARTIES CONTRACTANTES QUI DESIRAIENT ETRE MEMBRES DE L'UN OU L'AUTRE OU DE CHACUN DE CES GROUPES DE TRAVAIL DEVAIENT EN INFORMER LE SECRETARIAT AVANT SA PROCHAINE REUNION, QUI EST PREVUE POUR LE 25 JUIN ET LORS DE LAQUELLE SERONT CONSTITUES LES GROUPES DE TRAVAIL.

CONFORMEMENT AUX DISPOSITIONS PRISES PAR LES PARTIES CONTRACTANTES A LEUR VINGT ET UNIEME SESSION ET EN REPOSE AUX DEMANDES FORMULEES DANS LES DOCUMENTS L/2203 ET L/2204, UN CERTAIN NOMBRE DE PARTIES CONTRACTANTES ONT ADRESSE AU SECRETARIAT LES QUESTIONS QU'ELLES DESIRENT POSER CONCERNANT LES DISPOSITIONS ET LA MISE EN OEUVRE DES DEUX INSTRUMENTS D'ASSOCIATION SUSMENTIONNES. SUR LA BASE DE CES QUESTIONS, LE SECRETARIAT A ETABLI DEUX QUESTIONNAIRES QU'IL A TRANSMIS AUX ETATS MEMBRES DE LA COMMUNAUTE ET AUX PAYS ASSOCIES, EN LES PRIANT DE LUI COMMUNIQUER LEURS REPOSES AVANT LA FIN DU MOIS DE JUILLET. CES REPOSES SERONT ENSUITE DIFFUSEES.
