SUBJECT: MEETING OF TRADE NEGOTIATIONS COMMITTEE

THE NEXT MEETING OF THE COMMITTEE WILL BE HELD AT THE INTERNATIONAL LABOUR OFFICE IN GENEVA AT 3 P.M. ON MONDAY 13 JULY 1964.

AS WAS AGREED AT ITS MEETING ON 2 JULY THE COMMITTEE WILL REVIEW THE STATE OF THE PREPARATIONS IN THE AGRICULTURAL FIELD FOR THE FORTHCOMING TRADE NEGOTIATIONS. IT WILL ALSO CONTINUE THE DISCUSSION OF CERTAIN POINTS IN THE REPORT BY THE SUB-COMMITTEE ON THE TARIFF NEGOTIATING PLAN (DOCUMENT TN.64/29) WHICH WERE LEFT UNRESOLVED AT ITS LAST MEETING. THESE ARE (REFERENCES ARE TO TN.64/29):

- 1. WHEN COUNTRIES INDICATE IN THEIR EXCEPTIONS LIST THAT OFFERS OF LESS THAN THE LINEAR CUT CAN BE MADE, SHOULD THEY INDICATE AT THE SAME TIME PRECISELY WHAT OFFERS THEY CAN MAKE? (PARAGRAPH 2(a) (i1)).
- 2. THE PARTICIPATION IN THE PROCESS OF JUSTIFYING EXCEPTIONS LISTS OF COUNTRIES WHICH HAVE SUBMITTED AN OFFER IN A FORM AND ON TERMS AGREED BY THE TRADE NEGOTIATIONS COMMITTEE. (FOOTNOTE TO PAGE 2). THE CANADIAN DELEGATION WILL BE CIRCULATING A PAPER ON THIS POINT BEFORE THE MEETING.
- 3. THE TREATMENT OF MODUCTS PRIMARILY IMPORTED FROM NON-PARTICIPATING COUNTRIES (PABAGRAPH 2(c)).
- 4. THE MAXIMUM PERIOD FOR THE STAGING OF THE TARIFF REDUCTIONS (PARAGRAPH 2(g)). A PROPOSAL WILL BE CIRCULATED ON THIS POINT BEFORE THE MEETING.
