SUBJECT: MEETING OF COMMITTEE ON LEGAL AND INSTITUTIONAL FRAMEWORK

THE COUNCIL OF REPRESENTATIVES AT ITS MEETING ON 6 JULY DECIDED THAT THE NEXT MEETING OF THE LEGAL COMMITTEE SHOULD BEGIN ON 14 SEPTEMBER. HOWEVER, TO MEET THE CONVENIENCE OF CERTAIN DELEGATIONS IT HAS BEEN DECIDED THAT THE MEETING SHOULD BEGIN AT 3 PM ON 15 SEPTEMBER. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS.

THE BASIC DOCUMENT BEFORE THE COMMITTEE WILL BE THE DRAFT CHAPTER AS ANNEXED TO L/2195/REV.1. IN ADDITION THE SECRETARIAT WILL CIRCULATE ANY NOTIFICATIONS RECEIVED FROM CONTRACTING PARTIES IN RESPONSE TO THE REQUEST, CONTAINED IN GATT/AIR/405 OF 27 JULY 1964, FOR INDICATIONS OF MAINTENANCE OR WITHDRAWAL OF RESERVATIONS IN THE PRESENT DRAFT CHAPTER OR FOR NEW PROPOSALS SUBMITTED IN THE LIGHT OF DEVELOPMENTS SINCE THE COMMITTEE LAST MET.

IT WILL BE RECALLED THAT AT THEIR TWENTY-FIRST SESSION THE CONTRACTING PARTIES NOTED THAT THE UNITED NATIONS CONFERENCE ON TRADE AND DEVELOPMENT WOULD BE CONSIDERING MATTERS RELEVANT OR RELATED TO THE DRAFT CHAPTER. A SEPARATE SECRETARIAT DOCUMENT, WHICH WILL SHORTLY BE CIRCULATED FOR THE INFORMATION OF THE COMMITTEE, WILL CONTAIN A COMPARISON OF THE TEXTS OF THE DRAFT CHAPTER IN ITS PRESENT FORM WITH THE RECOMMENDATIONS AND RESOLUTIONS SET FORTH IN THE FINAL ACT OF THE UNITED NATIONS CONFERENCE ON TRADE AND DEVELOPMENT.

MEMBERS OF THE COMMITTEE, AND OTHER CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS, ARE REQUESTED TO ADVISE ME BY 11 SEPTEMBER OF THE NAMES OF THEIR REPRESENTATIVES.
