SUBJECT: WORKING PARTY ON EEC/TURKEY

THE COUNCIL OF REPRESENTATIVES AT ITS MEETING ON 6 JULY DECIDED THAT THE WORKING PARTY APPOINTED TO EXAMINE THE AGREEMENT CREATING AN ASSOCIATION BETWEEN THE EUROPEAN ECONOMIC COMMUNITY AND TURKEY SHOULD MEET DURING THE WEEK BEGINNING 21 SEPTEMBER. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS BEGINNING AT 3 PM ON 21 SEPTEMBER.

IN RESPONSE TO THE INVITATION OF CONTRACTING PARTIES, SEVERAL GOVERNMENTS PUT FORWARD QUESTIONS CONCERNING THE PROVISIONS AND IMPLEMENTATION OF THE ASSOCIATION AGREEMENT. THESE QUESTIONS, TOGETHER WITH THE ANSWERS PROVIDED BY THE MEMBER STATES OF THE COMMUNITY AND THE GOVERNMENT OF TURKEY, HAVE BEEN DISTRIBUTED IN DOCUMENT L/2251.

MEMBERS OF THE WORKING PARTY, AND OTHER CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS, ARE REQUESTED TO ADVISE ME BY 17 SEPTEMBER OF THE NAMES OF THEIR REPRESENTATIVES.
