SUBJECT: COMMITTEE ON BALANCE OF PAYMENTS RESTRICTIONS

1. THE COUNCIL OF REPRESENTATIVES AT ITS MEETING ON 6 JULY DECIDED THAT THE COMMITTEE ON BALANCE OF PAYMENTS RESTRICTIONS SHOULD MEET DURING THE PERIOD 2-13 NOVEMBER. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS BEGINNING AT 10 A.M. ON 2 NOVEMBER.
