SUBJECT: COUNCIL OF REPRESENTATIVES

AT THEIR MEETING ON 26 NOVEMBER (2SS/SR.4) THE CONTRACTING PARTIES DECIDED THAT A MEETING OF THE COUNCIL SHOULD BE HELD IN DECEMBER. THE DATES AGREED UPON WERE 16 AND 17, BUT ON EXAMINING THE PROGRAMME OF MEETINGS MORE CLOSELY I FEEL THAT THE MOST CONVENIENT TIME FOR THE COUNCIL TO MEET WOULD BE AT 3.PM ON THURSDAY, 17 DECEMBER, CONTINUING ON FRIDAY IF NECESSARY. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS.
