SUBJECT: MEETING OF COMMITTEE II

AT ITS MEETING ON 17-18 DECEMBER THE COUNCIL OF REPRESENTATIVES DECIDED THAT COMMITTEE II SHOULD MEET FROM 25 JANUARY TO 12 FEBRUARY 1965 TO EXAMINE THE NEW REGULATIONS OF THE COMMON AGRICULTURAL POLICY OF THE EUROPEAN ECONOMIC COMMUNITY AND TO CONSULT ALSO WITH OTHER CONTRACTING PARTIES WHICH HAVE MADE RECENT CHANGES IN THEIR AGRICULTURAL POLICIES. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS, BEGINNING AT 3 P.M. ON MONDAY, 25 JANUARY.

- 2. THE TEXTS OF THE NEW REGULATIONS OF THE COMMON AGRICULTURAL POLICY OF THE COMMUNITY, COVERING THREE GROUPS OF PRODUCTS, NAMELY DAIRY PRODUCTS, BEEF AND VEAL, AND RICE, HAVE BEEN DISTRIBUTED IN DOCUMENT L/2245. IN ADDITION, THE SECRETARIAT HAS PREPARED, IN COLLABORATION WITH THE EUROPEAN ECONOMIC COMMISSION, A DOCUMENT WHICH GIVES A DESCRIPTION OF THE NEW SYSTEMS FOR THESE THREE GROUPS OF PRODUCTS TAKING INTO ACCOUNT THE VARIOUS REGULATIONS WHICH HAVE BEEN ADOPTED FOR THE IMPLEMENTATION OF THE BASIC REGULATIONS. THIS PAPER HAS BEEN DISTRIBUTED IN DOCUMENT COM.II/137.
- 3. THE UNITED STATES GOVERNMENT IN NOTIFYING RECENT CHANGES IN ITS AGRICULTURAL POLICY HAS SUBMITTED THE TEXT OF AN ACT (PUBLIC LAW 88-482) TO PROVIDE FOR THE IMPOSITION OF QUOTAS ON CERTAIN MEAT AND MEAT PRODUCTS. THE RELEVANT PART OF THIS ACT HAS BEEN DISTRIBUTED IN DOCUMENT CQM.II/136.
- 4. A PAPER DESCRIBING RECENT CHANGES IN THE AGRICULTURAL POLICY OF THE UNITED KINGDOM WILL BE CIRCULATED IN TIME FOR THE MEETING OF THE COMMITTEE.
- 5. MEMBERS OF THE COMMITTEE, AND OTHER CONTRACTING PARTIES, ASSOCIATED GOVERN-MENTS AND INTITICOVERIMENTAL ORGANIZATIONS WISHING TO BE REPRESENTED BY OBSERVERS, ARE REQUESTED TO INFORM ME BY 22 JANUARY OF THE NAMES OF THEIR REPRESENTATIVES.
