SUBJECT: MEETING OF THE COMMITTEE ON TRADE AND DEVELOPMENT AND ESTABLISHMENT OF WORKING GROUPS

AT ITS MEETING IN MARCH, THE COMMITTEE ON TRADE AND DEVELOPMENT DECIDED TO HOLD ITS NEXT MEETING ON 29 AND 30 JUNE, PRIMARILY TO REVIEW THE WORK OF AND, AS APPROPRIATE, TO RECEIVE REPORTS FROM THE EIGHT WORKING GROUPS ESTABLISHED TO DEAL WITH THE DIFFERENT MATTERS ON THE COMMITTEE'S ADVIDA.

THE ATTENTION OF GOVERNMENTS IS DRAWN TO THE REPORTING PROCEDURES ADOPTED BY THE COMMITTEE WITH A VIEW TO ENSURING EFFECTIVE IMPLEMENTATION OF THE PROVI-SIONS OF THE NEW PART IV OF THE GENERAL AGREEMENT. IN PREPARATION FOR THE MEETING OF THE COMMITTEE, REPORTS UNDER POINTS (i) AND (ii) OF THE PROCEDURES SET OUT IN DOCUMENT L/2410, PARAGRAPH 11, SHOULD REACH THE SECRETARIAT PREFERABLY NOT LATER THAN 15 JUNE.

THE ATTENTION OF GOVERNMENTS IS ALSO PRAWN TO THE COMMITTEE'S REQUEST FOR THE SUBMISSION OF DOCUMENTATION AND SPECIFIC PROPOSALS, AS APPROPRIATE, IN REGARD TO THE WORK TO BE UNDERTAKEN BY THE FOLLOWING GROUPS:

- 1. AD HOC GROUP ON EXPANSION OF TRADE BETWEEN LESS-DEVELOPED COUNTRIES
- 2. WORKING GROUP ON PREFERENCES
- 3. WORKING GROUP ON COMMODITY PROBLEMS (DOCUMENT L/2410, PARAGRAPHS 14, 25, 37 AND 42).

CONTRACTING PARTIES WISHING TO PARTICIPATE IN THE WORK OF THESE GROUPS AND ALSO OF THE GROUP ON RESIDUAL RESTRICTIONS ARE REQUESTED TO INFORM ME BY 25 APRIL.
