SUBJECT: COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS

1. AT THEIR MEETING ON 25 MARCH, THE CONTRACTING PARTIES DECIDED THAT THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS SHOULD MEET DURING THE PERIOD 5-14 MAY. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS BEGINNING AT 3 P.M. ON 5 MAY.

2. THE FOLLOWING LIST SHOWS THE COUNTRIES WHICH WILL BE CONSULTING DURING THIS PERIOD AND THE TIME PROPOSED FOR THE BEGINNING OF EACH CONSULTATION.

TURKEY - 3 P.M. ON 5 MAY
UNITED ARAB REPUBLIC - 10 A.M. ON 6 MAY
ICELAND - 10 A.M. ON 7 MAY
SOUTH AFRICA - 3 P.M. ON 10 MAY

3. AS EXPLAINED IN GATT/AIR/457, THE COMMITTEE WILL ALSO BE ASKED TO DRAW UP A REPORT ON THE BALANCE-OF-PAYMENTS ASPECT OF THE 10 PER CENT REGULATORY DUTY RECENTLY IMPOSED BY THE GOVERNMENT OF INDIA. IT IS PROPOSED THAT THE COMMITTEE SHOULD CONSIDER THIS MATTER AT A MEETING ON 11 MAY.

4. MEMBERSHIP OF THE COMMITTEE IS SHOWN IN L/2248.

5. BASIC DOCUMENTS FOR THESE CONSULTATIONS HAVE BEEN OR WILL BE DISTRIBUTED IN THE BOP/- SERIES. PAPERS SUPPLIED BY THE INTERNATIONAL MONETARY FUND WILL BE FORWARDED TO CONTRACTING PARTIES IN THE USUAL MANNER.

6. MEMBERS OF THE COMMITTEE AND THE CONSULTING CONTRACTING PARTIES, AS WELL AS ANY OTHER CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS AT THESE MEETINGS, ARE REQUESTED TO NOTIFY ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
