SUBJECT: COUNCIL OF REPRESENTATIVES - MEETING ON 12-13 JULY

AS AGREED BY THE COUNCIL ON 28 MAY THE NEXT MEETING WILL BE HELD IN THE PALAIS DES NATIONS BEGINNING AT 3 P.M. ON 12 JULY AND CONTINUING ON 13TH AS NECESSARY.

THE FOLLOWING ITEMS ARE PROPOSED FOR INCLUSION IN THE AGENDA:

1. SOUTH AFRICA/RHODESIA TRADE RELATIONS. THE REPORT OF THE WORKING PARTY HAS BEEN DISTRIBUTED IN L/2439.

2. UNITED KINGDOM TEMPORARY IMPORT CHARGES. THE WORKING PARTY RESUMED THE CONSULTATIONS WITH THE UNITED KINGDOM ON 16 18 JUNE AND WILL SUBMIT A REPORT TO THE COUNCIL (L/2446).

3. INDIAN IMPORT LEVY. A COMMUNICATION FROM THE GOVERNMENT OF INDIA CIRCULATED IN GATT/AIR/457 REFERRED TO A STATEMENT MADE IN THE INDIAN PARLIAMENT BY THE UNION FINANCE MINISTER. THIS STATEMENT HAS NOW BEEN DISTRIBUTED IN DOCUMENT L/2447.

4. APPOINTMENT OF COMMITTEES AND WORKING PARTIES

- (A) COMMITTEE ON BUDGET FINANCE AND ADMINISTRATION
- (B) WORKING PARTY ON BELATIONS WITH POLAND
- (C) WORKING PARTY ON ARAB COMMON MARKET

5. <u>ARTICLE XXIV:6</u>, NEGOTIATIONS BY GREECE. A DOCUMENT WILL BE CIRCULATED BEFORE THE MEETING.

COUNCIL MEMBERS ARE REQUESTED TO ADVISE ME BY 9 JULY OF THE COMPOSITION OF THEIR DELEGATIONS. CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS, NOT MEMBERS OF THE COUNCIL, AND INTERGOVERNMENTAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS, SHOULD INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES.
