SUBJECT: COMMITTEE ON TRADE AND DEVELOPMENT - PROGRAMME OF MEETINGS

1. AT ITS JULY MEETING, THE COMMITTEE AGREED TO RECONVENE LATER IN THE YEAR. IT WAS ALSO AGREED THAT THE SUB-GROUPS ESTABLISHED BY THE COMMITTEE SHOULD MEET IN ACCORDANCE WITH A TIME SCHEDULE TO BE DRAWN UP IN CONSULTATION WITH THE CHAIRMAN OF THE COMMITTEE AND THE CHAIRMEN OF THE SUB-GROUPS.
